





"Traffic flow along the road is very heavy at peak times.

Outside of these times traffic is lighter but speed is then an issue.

When walking children to school it is very difficult to cross the road with the school crossing by Garnedd being the only safe option the Bangor side of the Hospital.

When school crossing not in operation can at times be difficult to cross. Even when at Garnedd cars will not stop. Possible solution would be to have zebra / pelican crossing at school which is mandatory and at other locations such as top of Coed Mawr and Beulah chapel which would allow safer crossing spaces and act as a means to slow traffic down."

*"if it was not so dangerous I would walk more often I love walking but, I find it terrible trying to cross the road to brewery fields for a walk or to cross the road to get the bus to town from the top of Coed Mawr hill as there is no crossing and the cars travel fast so I feel trapped I have to pay for a taxi to the shops rather than cross the road for the bus,
unfortunately very few buses go from Coed Mawr I have to walk up the steep hill to get a bus and put my life at risk crossing the road to get a bus....."*



"It is very dangerous to walk or cycle along Penrhos road so I always have to use the car especially when taking the kids anywhere. If the road was safer then I would definitely be more inclined to use my bike to get into town and so would my children. The main problem is the speed at which cars travel. These plans look great and would definitely improve things for walkers and cyclists and make it more likely that people could walk or cycle instead of using their cars. The best thing though would be to make the road 20mph as soon as the council can to reduce accidents . There was another accident on Penrhos road this morning because its so busy and people are in a rush to get to school / work ."




