Cynhelir yr ysgol gan Gyngor Gwynedd.

Cynhaliodd Cyngor Gwynedd gyfnod ymgynghori cyn penderfynu cyhoeddi'r cynnig hwn. Cynigir gweithredu'r cynnig ar **31 Rhagfyr 2021**.

Yn ddarostyngedig ar ddewis rhieni bydd disgyblion cyfredol Ysgol Abersoch yn trosglwyddo i Ysgol Sarn Bach, Sarn Bach, Gwynedd, LL53 7LF ar 1 Ionawr 2022. Mae yr ysgol yn Ysgol Gymuned Cyfrwng Cymraeg i enethod a bechgyn 3 i 11 oed wedi ei leoli ym mhentref Sarn Bach.

Bydd dalgylch Ysgol Sarn Bach o Ionawr 2022 yn cynnwys dalgylch yr ysgol fel ag y mae heddiw, a dalgylch presennol Ysgol Abersoch. Yr awdurdod mynediad ar gyfer Ysgol Sarn Bach fydd Cyngor Gwynedd a bydd disgyblion yn cael eu derbyn i'r ysgol gan Gyngor Gwynedd yn unol â'i Bolisi Mynediad. Bydd y trefniadau mynediad i'r ysgol yn cael eu gwneud heb gyfraniad at allu na medr (bandio disgyblion).

Bydd cludiant yn cael ei ddarparu i'r ysgol yn unol â Pholisi Cludiant Ysgolion Cyngor Gwynedd.

Cyngor Gwynedd yw'r awdurdod cynhaliol a Chyngor Gwynedd fydd yn gweithredu'r cynnig yma.

Mae'r cynnig hwn wedi ei lunio o ganlyniad i'r angen i gyfarch y niferoedd isel o ddisgyblion sy'n mynychu Ysgol Abersoch ac o ganlyniad, maint bychain y dosbarthiadau, yn ogystal â rhagamcanion isel o niferoedd i'r dyfodol. Nid oedd yr un o'r opsiynau eraill a adnabuwyd ar gyfer yr ysgol, gan gynnwys ffederaleiddio, yn mynd i'r afael a'r materion hyn. Fel canlyniad ystyrir mai cau'r ysgol yw'r ymateb mwyaf priodol.

### NOTICE OF PROPOSAL TO DISCONTINUE YSGOL ABERSOCH

GWYNEDD COUNCIL, COUNCIL OFFICES, CAERNARFON, GWYNEDD, LL55 1SH

Notice is hereby given in accordance with Section 43 of the School Standards and Organisation (Wales) Act 2013 and the School Organisation Code that Gwynedd Council, having consulted such persons as required, propose to discontinue YSGOL ABERSOCH, Lon Gwydryn, Abersoch, Gwynedd, LL53 7EA. The school is currently maintained by Gwynedd Council.

Gwynedd Council undertook a period of consultation before deciding to publish this proposal. A consultation report containing a summary of the issues raised by consultees, the proposer's responses and Estyn's full response is available on [www.gwynedd.llyw.cymru/modernisingeducation](http://www.gwynedd.llyw.cymru/modernisingeducation).

It is proposed to implement the proposals on **31 December 2021**.

Subject to parental choice, current Ysgol Abersoch pupils will transfer to Ysgol Sarn Bach, Sarn Bach, Gwynedd, LL53 7LF on 1 January 2022. The school is a Welsh Medium Community School for girls and boys aged 3-11 and is located in the village of Sarn Bach.

The catchment area of Ysgol Sarn Bach from 1 January 2022 will include the catchment area of the present school as it is today, and Ysgol Abersoch's present catchment area. The admission authority for Ysgol Sarn Bach is Gwynedd Council and pupils will be admitted in accordance with the Authorities Admissions Policy. The admissions arrangements for the school will not make provision for selection by aptitude or ability (pupil banding).

Transport will be provided to the school in accordance with Gwynedd Council's School Transport Policy.

Gwynedd Council is the maintaining authority and will implement the proposal.

This proposal has been formulated as a result of the need to address the low numbers of pupils attending Ysgol Abersoch and consequently the small class sizes, as well as low projections for future numbers. None of the other options identified for the school, including federalisation, addressed these issues. As a result, closing the school is considered the most appropriate solution.

Within a period of 28 days of the date on which the proposal was published, that is to say by **23 July 2021**, any persons may object to the proposal.

#### EXPLANATORY NOTE

(The following is not part of the notice but is intended to explain its general purpose)

Following a consultation process Gwynedd Council propose to close Ysgol Abersoch on 31 December 2021 and offer a place for pupils at Ysgol Sarn Bach from the 1 January 2022.

In accordance with the Authorities admissions policy, parents are entitled to apply for admission (or transfer request) to any school.

Free school transport provision will be offered to pupils in accordance with Gwynedd Council's School Transport Policy.
