TAX: More than 10.2 million Self Assessments filed by 31 January 2022

More than eight out of ten people – 10.2 million – who submit Self Assessment tax returns did so by the 31 January 2022 deadline. Anyone who didn't submit their return now have until 28 February 2022 to do so and avoid a penalty. More on this at:
