- Efallai fydd angen i chi drafod gyda safleoedd cyfagos i sicrhau pellter rhwng e.e. dau grwp o gwsmeriaid.
- Defnyddiwch dulliau o farciau sydd ddim yn parhaol, megis sialc, ar balmentydd yn hytrach na dulliau eraill o farcio a allai beri rhwystr neu faglu rhywun.

Gwiriwch fod gan staff ddim symptomau cyn eu gadael ar y safle

Gosodwch hylif diheintio dwylo wrth y drws, ac mewn prif fannau gwaith eich staff

6

Sicrhewch fod offer glanhau yn barod at ddefnydd eich staff, a'u bod yn deall lle sydd angen ei lanhau, a pa mor aml

- pobl o'r un cartref
- unigolion a'u gofalwyr

# Reopening Your Business

## 6 Things to Remember



**1**

Take all reasonable steps to keep everyone (including staff and customers) two metres apart\* by:

- marking the floor
- displaying signs
- using a one-way system when there isn't a two metre gap available for people to pass each other
- ensuring you don't let too many people on site at once

**2**

Consider the space outside your site, and where possible mark queueing lines to ensure that people do not wait within two metres of the entrance or exit. Mark out queueing distances of two metres.

- You may need to discuss this with neighbouring sites to ensure sufficient distance between e.g. two groups of customers.
- Use non-permanent methods of marking, such as chalk on pavements rather than other methods which could cause a blockage or trip-hazard

**3**

Ensure that you have displayed signage by the door and around the site

**4**

Check that staff do not have any symptoms before allowing them on site

**5**

Place hand sanitiser at the door, and at your staff's main work stations

**6**

Ensure that cleaning equipment is ready for use by staff, and that they understand where needs cleaning, and how often

\*The following people do not need to stay 2m apart:

- people from the same household
- individuals and their carers

# Working Together

**Play your Part** by doing everything possible to keep your staff and customers safe

**Be Patient** - it's going to take time for things to settle, and it's likely that some things won't get fully back to normal
