GORCHYMYN DIOGELU MANNAU CYHOEDDUS CYNGOR
GWYNEDD (ALCOHOL AC YMDDYGIAD GWRTHGYMDEITHASOL)
(BANGOR) 2025

Mae Cyngor Gwynedd ("y Cyngor"), drwy arfer y grym a roddwyd iddo gan adran 59 ac adran 60 o'r Ddeddf Ymddygiad Gwrthgymdeithasol, Trosedd a Phlisma 2014 (y Ddeddf), yn gwneud y Gorchymyn canlynol:

1. Enw'r Gorchymyn hwn yw "Gorchymyn Diogelu Mannau Cyhoeddus Cyngor Gwynedd (Alcohol ac Ymddygiad Gwrthgymdeithasol) (Bangor) 2025" (y Gorchymyn hwn).
2. Daw'r Gorchymyn hwn i rym ar 1 Rhagfyr 2025 a bydd yn parhau mewn grym am gyfnod o 3 blynedd hyd 30 Tachwedd 2028, oni bai y caiff yn y cyfamser ei ddiddymu, ei ddiwygio, neu ei ymestyn gan orchymyn pellach yn unol â hawliau statudol y Cyngor.
3. Ar 8fed o Dachwedd 2019 fe wnaeth y Cyngor orchymyn a elwir yn "Gorchymyn Diogelu Mannau Cyhoeddus Cyngor Gwynedd (Alcohol ac Ymddygiad Gwrthgymdeithasol) (Bangor) 2019" (Gorchymyn 2019) ac fe ddaeth i ben ar 30ain o Dachwedd 2022.
4. Ar 9fed o Dachwedd 2022 fe wnaeth y Cyngor orchymyn (Gorchymyn 2022) i ymestyn Gorchymyn 2019, ac y mae Gorchymyn 2022 yn dod i ben ar 30ain o Dachwedd 2025.
5. Mae'r Gorchymyn hwn yn berthnasol i'r ardal a amlinellir yn ddu ac a arlliwir yn las golau ar y cynllun a atodwyd yn Atodlen 1 i Gorchymyn 2019, ac y mae copi ohono ynghlwm i'r Gorchymyn hwn.
6. Y mae'r Cyngor yn fodlon o'r farn bod seiliau rhesymol yn bodoli fel bod hi'n angenrheidiol (i) atal gweithgareddau neu atal ail adrodd gweithgareddau sydd wedi cael eu hadnabod yn Gorchymyn 2019, neu (ii) bod cynnydd ym maint neu ddifrifoldeb y gweithgareddau a adnabyddir yn Gorchymyn 2019; ac er pwrpas (i) a (ii) fe fyddai'r gweithgareddau yn digwydd ar ôl i Orchymyn 2019 ac Gorchymyn 2022 ddod i ben.
7. O'r dyddiad y daw'r Gorchymyn hwn i rym a hyd pan ddaw i ben y mae'r Gorchymyn hwn yn darparu bod darpariaethau Gorchymyn 2019 eto yn cael eu

hadnewyddu, ac y bydd y darpariaethau hynny mewn grym ac yn effeithiol a gellir eu gorfodi.

8. Yn unol ag adran 66 o'r Ddeddf, gall unrhyw berson a diddordeb sydd yn dymuno herio dilysrwydd y Gorchymyn hwn ar y sail nad oedd gan y Cyngor y hawl i wneud y Gorchymyn hwn neu fod diffyg cydymffurfiaid a gofyniad o'r Ddeddf wneud cais i'r Uchel Lys o fewn 6 wythnos o'r dyddiad y gwnaethpwyd y Gorchymyn

GWYNEDD COUNCIL (ALCOHOL AND ANTI-SOCIAL BEHAVIOUR) (BANGOR) PUBLIC SPACES PROTECTION ORDER 2025

Gwynedd Council ("the Council"), in exercise of the powers conferred upon it by section 59 and section 60 of the Anti-social Behaviour, Crime and Policing Act 2014 ("the Act"), makes the following Order:

1. The name of this Order is the "Cyngor Gwynedd (Alcohol and Anti-Social Behaviour) (Bangor) Public Spaces Protection Order 2025" (this Order).
2. This Order comes into force on 1st December 2025 and shall remain in force for a period of 3 years until 30 November 2028, unless in the meantime it is revoked, amended or extended by further order under the Council's statutory powers.
3. On 8th November 2019 the Council made an order named "Gwynedd Council (Alcohol and Anti-Social Behaviour) (Bangor) Public Spaces Protection Order 2019" (the 2019 Order), and it expired on 30th November 2022.
4. On 9th November 2022 the Council made an order (the 2012 Order) to extend the 2019 Order, and the 2012 Order comes to an end on 30th November 2025.
5. This Order applies to the area outlined in black and shaded light blue on the plan in Schedule 1 to the 2019 Order, and a copy of the same is attached to this Order. .
6. The Council are satisfied on reasonable grounds that further extending the 2019 Order is necessary to (i) prevent an occurrence or reoccurrence of the activities identified in the 2019 Order or (ii) to prevent an increase in the frequency or seriousness of the activities identified in the 2019 Order; and for (i) and (ii) those activities would have happened after the expiration of the 2019 Order and the 2022 Order.
7. From the date this Order comes into force and until its expiry this Order provides that the provisions of the 2019 Order shall be further renewed and shall be in force, and the said provisions shall be effective and enforceable.

8. In accordance with section 66 of the Act, any interested person who wishes to challenge the validity of this Order on the grounds that the Council did not have the power to make this Order or that a requirement under the Act has not been complied with may apply to the High Court within 6 weeks from the date upon which this Order is made.

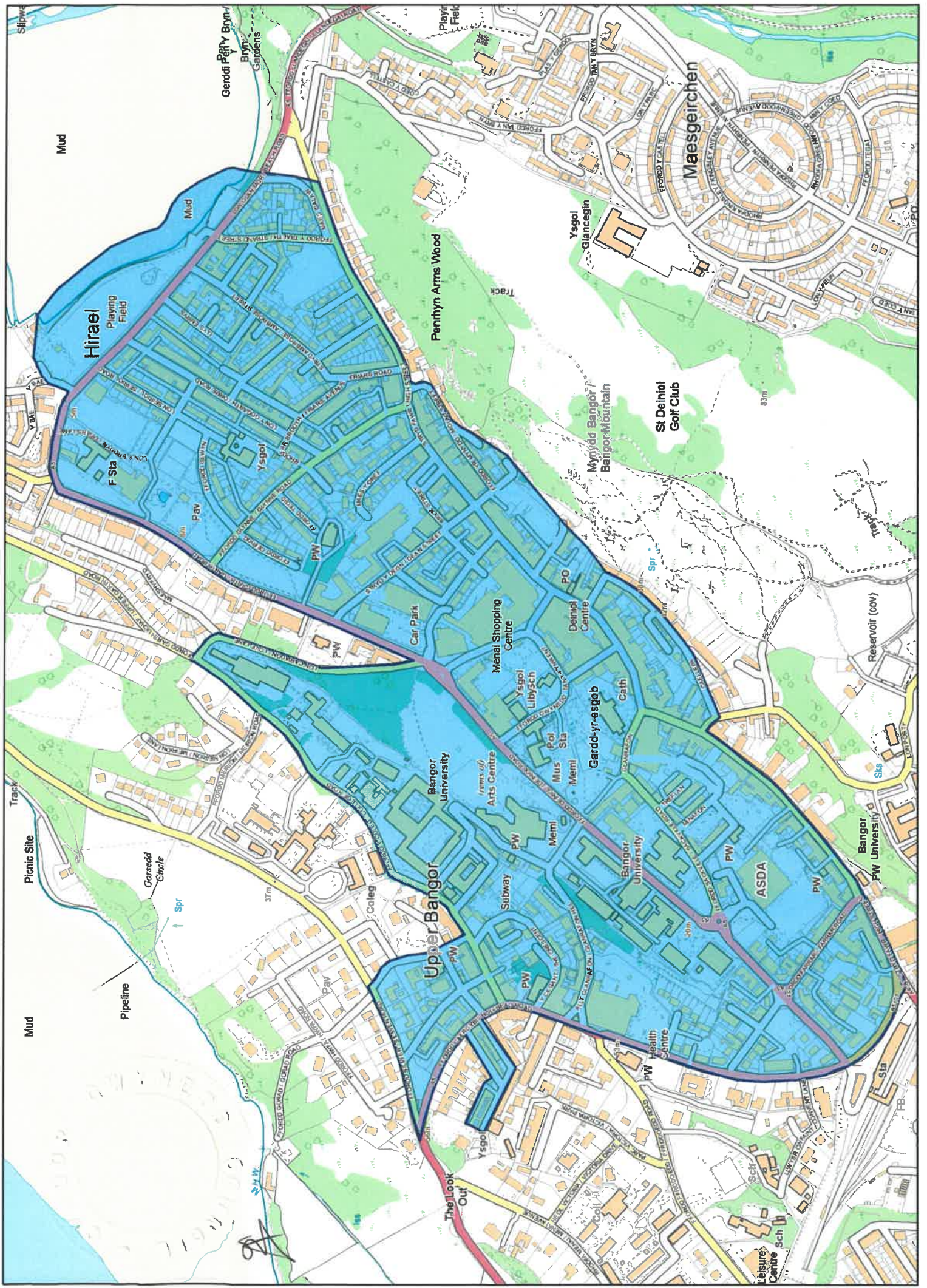
