1. Yn ddarostyngedig i erthygl 2 isod, mae'r Cyngor wedi penderfynu diddymu gorchymyn a wnaed ganddo o dan adran 13(2) o'r Ddeddf Cyfiawnder Troseddol a Heddlu 2001 sydd o ganlyniad i adran 75(3) o Ddeddf 2014 i'w drin fel Gorchymyn Diogelu Mannau Cyhoeddus, sef y Gorchymyn Yfed Alcohol Mewn Mannau Cyhoeddus Dynodedig ar gyfer ardaloedd Bangor a Chaernarfon Cyngor Gwynedd 2004 ("y Gorchymyn").
2. Diddymir y Gorchymyn dim ond i'r graddau ei fod yn berthnasol i Fangor, Gwynedd.
3. Bydd y Gorchymyn i'r graddau y'i diddymir yn darfod â bod yn weithredol ar 1 Rhagfyr 2019.

NOTICE OF DISCHARGE OF PUBLIC SPACES PROTECTION ORDER

Gwynedd Council ("the Council") in exercise of the powers conferred on it by section 61(4) of the Anti-social Behaviour, Crime and Policing Act 2014 ("the 2014 Act") and regulation 3 of the Anti-social Behaviour, Crime and Policing Act 2014 (Publication of Public Spaces Protection Orders) Regulations 2014/2591, hereby gives the following Notice:

1. Subject to article 2 below, the Council has decided to discharge an order made by it under section 13(2) of the Criminal Justice and Police Act 2001 which by virtue of section 75(3) of the 2014 Act is to be treated as a Public Spaces Protection Order, namely the Gwynedd Council Alcohol Consumption in Designated Public Places for the areas of Bangor and Caernarfon Order 2004 ("the Order").
2. The Order shall be discharged only to the extent that it applies to Bangor, Gwynedd.
3. The Order to the extent discharged shall cease to have effect on 1 December 2019.
