

**GORCHYMYN CYNGOR GWYNEDD**

1. Gwahardd a chyfyngu cerbydau rhag aros unrhyw amser ar yr ochr darn ffordd a bennir yn Atodlen 1 isod.
2. Defnyddir y rhan hwnnw o'r ffordd y cyfeirir ato yn Atodlen 1 isod fel safle parcio cerbydau personau anabl sydd yn arddangos bathodyn person anabl.
3. Diddymu cyfyngiadau aros ar yr ochr darn ffordd a bennir yn Atodlen 2 isod
4. Bydd eithriadau yn caniatáu aros o dan rhai amgylchiadau fel y nodi'r yn y Gorchymyn.

**THE CYNGOR GWYNEDD**  
**(PROHIBITION AND RESTRICTION OF WAITING AND STREET PARKING PLACES AND**  
**REVOCAION) (ARFON AREA NO. 30) ORDER 2026**

On the 27<sup>th</sup> day of April, 2026 Cyngor Gwynedd made the above Order in exercise of the powers conferred by the Road Traffic Regulation Act 1984, as amended and of all other powers them enabling and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Road Traffic Regulation Act 1984.

The effect of the Order when it comes into force on the 6<sup>th</sup> May, 2026 will be to:-

1. Prohibit and restrict vehicles from waiting on the side of length of the road referred to in Schedule 1 hereto.
2. The part of road specified in Schedule 1 hereto shall be used as a parking place for a disabled person's vehicle displaying a disabled person's badge
3. Revoke the waiting restrictions on the side of length of the road referred to in Schedule 2 hereto.
4. Exceptions will permit waiting in certain circumstances as set out in the Order.

Full details are contained in the Order which, together with the maps showing the lengths of roads concerned and a statement of the Council's reasons for making the Order are available. Any person wishing to question the validity of the Order on the grounds that it is not within the powers conferred by the Road Traffic Regulation Act 1984 or on the ground that any regulations made under the act were not complied with in relation to the Order or any part of it may make application to the High Court for that purpose within six weeks of the date of publication of this notice.
