

GORCHYMYN CYNGOR GWYNEDD
(GWAHARDD A CHYFNGU AROS A MANNAU PARCIO AR Y STRYD)
(ARDAL MEIRIONNYDD RHIF 13) 2025

Ar y 7fed o Fai, 2025 gwnaed y gorchymyn uchod gan Gyngor Gwynedd trwy ymarfer ei bwerau o dan y Ddeddf Rheoli Traffig y Ffyrdd 1984 fel y newidiwyd a phob pŵer galluogi arall ac ar ôl ymgynghori gyda Phrif Swyddog yr Heddlu yn unol â Rhan III o Atodlen 9 o'r Ddeddf.

Pan ddaw'r Gorchymyn i rym ar y 19eg o Fai, 2025 ei effaith fydd:-

1. Gwahardd cerbydau rhag aros unrhyw amser ar yr ochrau darnau ffyrdd a bennir yn Atodlen 1 isod.
2. Caniatáu i ddeilydd y cerdyn parcio aros ar yr ochrau ffyrdd a bennir yn Atodlen 1 isod yn amodol ar y taliadau Trwydded fel y soniwyd isod.
3. Diddymu cyfyngiadau aros ar yr ochr darn ffordd a bennir yn Atodlen 2 isod

Bydd eithriadau yn caniatáu aros ar gyfer:-

- (a) codi a gollwng teithwyr;
- (b) llwytho neu ddadlwyo nwyddau;
- a lle bo hynny'n angenrheidiol yng nghyswllt:-
- (c) rhai gweithfeydd adeiladu;
- (ch) cynnal y ffordd;
- (d) cyflenwi nwy, trydan a dŵr neu waith statudol;
- (dd) cyflawni pwerau a swyddogaethau awdurdod lleol;
- (e) i bwrpasau'r post;
- (f) i bwrpas yr heddlu, brigâd dân neu ambiwlans;
- (ff) ac o dan rhai amgylchiadau lle bo'r cerbyd yn gerbyd person methodig.

THE CYNGOR GWYNEDD
(PROHIBITION AND RESTRICTION OF WAITING AND STREET PARKING PLACES)
(MEIRIONNYDD AREA NO. 13) – ORDER 2025

On the 7th May, 2025 Cyngor Gwynedd made the above Order in exercise of the powers conferred by the Road Traffic regulation Act 1984, as amended and of all other powers them enabling and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act.

The effect of the Order when it comes into effect on the 19th May, 2025 will be as follows:

1. Prohibit vehicles from waiting on the sides of lengths of various roads referred to in Schedule 1 hereto.
2. Allow Permit Holders to wait on the sides of lengths of roads referred to in Schedule 1 hereto subject to the Permit Charges as mentioned below.
3. Revoke the waiting restrictions on the sides of lengths of the roads referred to in Schedule 2 hereto.

Exceptions will permit waiting for:-

- (a) picking up and setting down passengers;
 - (b) loading or unloading goods;
- and where necessary in connection with:-
- (c) certain building operations;
 - (d) the maintenance of the road;
 - (e) the supply of gas, electricity, water or other statutory undertakings;
 - (f) the exercise of local authority powers and functions;
 - (g) the exercise of postal functions;
 - (h) fire brigade, ambulance and police purposes;

(i) and in certain circumstances when the vehicle is a disabled person's vehicle.

The Order, together with the map showing the road concerned, is available for inspection during normal business hours at:-

- (a) Council Offices, Dolgellau (b) Post Office, Dolgellau (c) Public Library, Dolgellau.

Full details are contained in the Order which, together with the map showing the length of road concerned and a statement of the Council's reasons for making the Order are available. Any person wishing to question the validity of the Order on the grounds that it is not within the powers conferred by the Road Traffic Regulation Act 1984 or on the ground that any regulations made under the act were not complied with in relation to the Order or any part of it may make application to the High Court for that purpose within six weeks of the date of publication of this notice.
