THE CYNGOR GWYNEDD
(MARCUS STREET, CAERNARFON)
(ONE WAY TRAFFIC) ORDER 2023

NOTICE IS HEREBY GIVEN that Cyngor Gwynedd have made an Order under Section 1(1) and (2) 2(1) to (3), 4 (2) and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984.

The effect of the Order will be to prohibit any person from causing any vehicle to proceed along the road specified in the first column of the schedule hereto save in the direction specified in the schedule.

The Order, together with a map showing the length of road concerned and a Statement of the Council's reasons for proposing to make the Order, may be examined at:-

- (a) Council Offices, Shirehall Street, Caernarfon;
- (b) The Public Library, Caernarfon

during normal business hours.

This Order shall come into operation on the 20th day of February, Two thousand and Twenty Three and may be cited as "The Gwynedd Council (Marcus Street, Caernarfon) (One-Way Traffic) Order 2023".

Any person wishing to question the validity of the Order on the grounds that it is not within the powers conferred by the Road Traffic Regulation Act 1984 or on the ground that any regulations made under the act were not complied with in relation to the Order or any part of it may make application to the High Court for that purpose within six weeks of the date of publication of this notice.
