NOTICE IS HEREBY GIVEN that Cyngor Gwynedd proposes to make an Order under Section 1(1) and (2) 2(1) to (3), 4 (2) and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984.

The effect of the Order will be to prohibit any person from causing any vehicle to proceed along the road specified in the first column of the schedule hereto save in the direction specified in the second column of the schedule.

The draft Order, together with a map showing the length of road concerned and a Statement of the Council's reasons for proposing to make the Order, may be examined at:-

- (a) Council Offices, Shirehall Street, Caernarfon;
- (b) The Public Library, Caernarfon

during normal business hours.
