

GORCHYMYN CYNGOR GWYNEDD
GWAHARDDIADAU, CYFYNGU AROS A
MANNAU PARCIO AR Y STRYD A DIRYMU
(ARDAL MEIRIONNYDD RHIFAU 7 AC 8) 2022

Ar y 30ain dydd o Dachwedd, 2022 gwnaed y Gorchymyn uchod gan Gyngor Gwynedd trwy ymarfer ei bwerau o dan y Ddeddf Rheoli Traffig y Ffyrdd 1984, fel y newidiwyd a phob pŵer galluogi arall ac ar ôl ymgynghori gyda Phrif Swyddog yr Heddlu yn unol â Rhan III o Atodlen 9 o Ddeddf Rheoli Trafnidiaeth Ffyrdd 1994.

Pan ddaw'r Gorchymyn i rym ar y 14eg o Ragfyr, 2022 ei effaith fydd:-

1. Gwahardd a chyfyngu cerbydau rhag aros unrhyw amser ar yr ochr darn ffordd a bennir yn Atodlen 1 isod.
2. Defnyddir y rhan hynny o'r ffordd y cyfeirir ati yn Atodlen 2 isod fel safle parcio cerbydau personau anabl sydd yn arddangos bathodyn person anabl.
3. Diddymu cyfyngiadau aros ar yr ochr darn ffordd a bennir yn Atodlen 3 isod
4. Bydd eithriadau yn caniatáu aros o dan rhai amgylchiadau fel y nodi'r yn y Gorchymyn.

Roedd Cyngor Gwynedd wedi bwriadu cynnwys y ffyrdd isod yn y Gorchymyn ond penderfynwyd gohirio eu cynnwys am y tro:

(i) Ffordd Dosbarth III - Cyffordd i Bentre Gwynfryn - Ar ochr ogleddol y ffordd wrth ei chyffordd i Bentre Gwynfryn a;

(ii) Ffordd Ddi-Ddosbarth - Ffordd sy'n arwain i Bentre Gwynfryn - Ar ddwy ochr y ffordd wrth ei gyffordd a'r ffordd sy'n arwain at Bentref Llanbedr;

THE GWYNEDD COUNCIL
PROHIBITION AND RESTRICTION OF WAITING
AND STREET PARKING PLACES AND REVOCATION
(MEIRIONNYDD AREA NOS. 7 AND 8) ORDER 2022

On the 30th November, 2022 Gwynedd Council made the above Order in exercise of the powers conferred by the Road Traffic Regulation Act 1984, as amended and of all other powers them enabling and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Road Traffic Regulation Act 1994.

The effect of the Order when it comes into force on the 14th December, 2022 will be to:-

1. Prohibit and restrict vehicles from waiting on the sides of lengths of the roads referred to in Schedule 1 hereto.
2. The part of road specified in Schedule 2 hereto shall be used as a parking place for a disabled person's vehicle displaying a disabled person's badge
3. Revoke the waiting restrictions on the sides of lengths of the roads referred to in Schedule 3 hereto.
4. Exceptions will permit waiting in certain circumstances as set out in the draft Order.

Cyngor Gwynedd had initially proposed to include:-

(i) the Class III Road - Junction to Pentre Gwynfryn, Llanbedr - On the northern side of the road at its junction to Pentre Gwynfryn and;

(ii) the Unclassified Road - Road leading to Pentre Gwynfryn, Llanbedr - On both sides of the road at its junction with the Class III Road leading to Llanbedr Village.

in the Order but has decided for the time being to defer the proposal, and not to include the same in the current Order.

Any person wishing to question the validity of the Order on the grounds that it is not within the powers conferred by the Road Traffic Regulation Act 1984 or on the ground that any regulations made under the act were not complied with in relation to the Order or any part of it may make application to the High Court for that purpose within six weeks of the date of publication of this notice.
