THE GWYNEDD COUNCIL
(CLOSURE OF UNICORN LANE DOLGELLAU)
(TEMPORARY PROHIBITION OF THROUGH TRAFFIC) ORDER 2020

NOTICE IS HEREBY GIVEN that the Gwynedd Council have made an Order, the effect of which is to prohibit any person from causing any vehicle except pedal cyclist to proceed in either direction along that length of the Unclassified road known as Unicorn Lane Dolgellau from its junction with Smithfield Square for a distance of 30 meters in a south westerly direction.

The Order is required to avoid the likelihood of danger to the public as a consequence for the requirement for pedestrians and pedal cyclist to maintain social distancing as a result of the coronavirus pandemic and the potential conflict with vehicle traffic.

The alternative route is to proceed from the closure at the junction with Smithfield Square travelling in a westerly direction along the Porth Marchnad road to its junction with Meyrick Street. Turn left at the junction and travel along to its junction with Unicorn Lane. Turn left at the junction and proceed up to the closure.

The Order comes into effect on the 27th August, 2020 and will continue in force for a period not exceeding eighteen months.

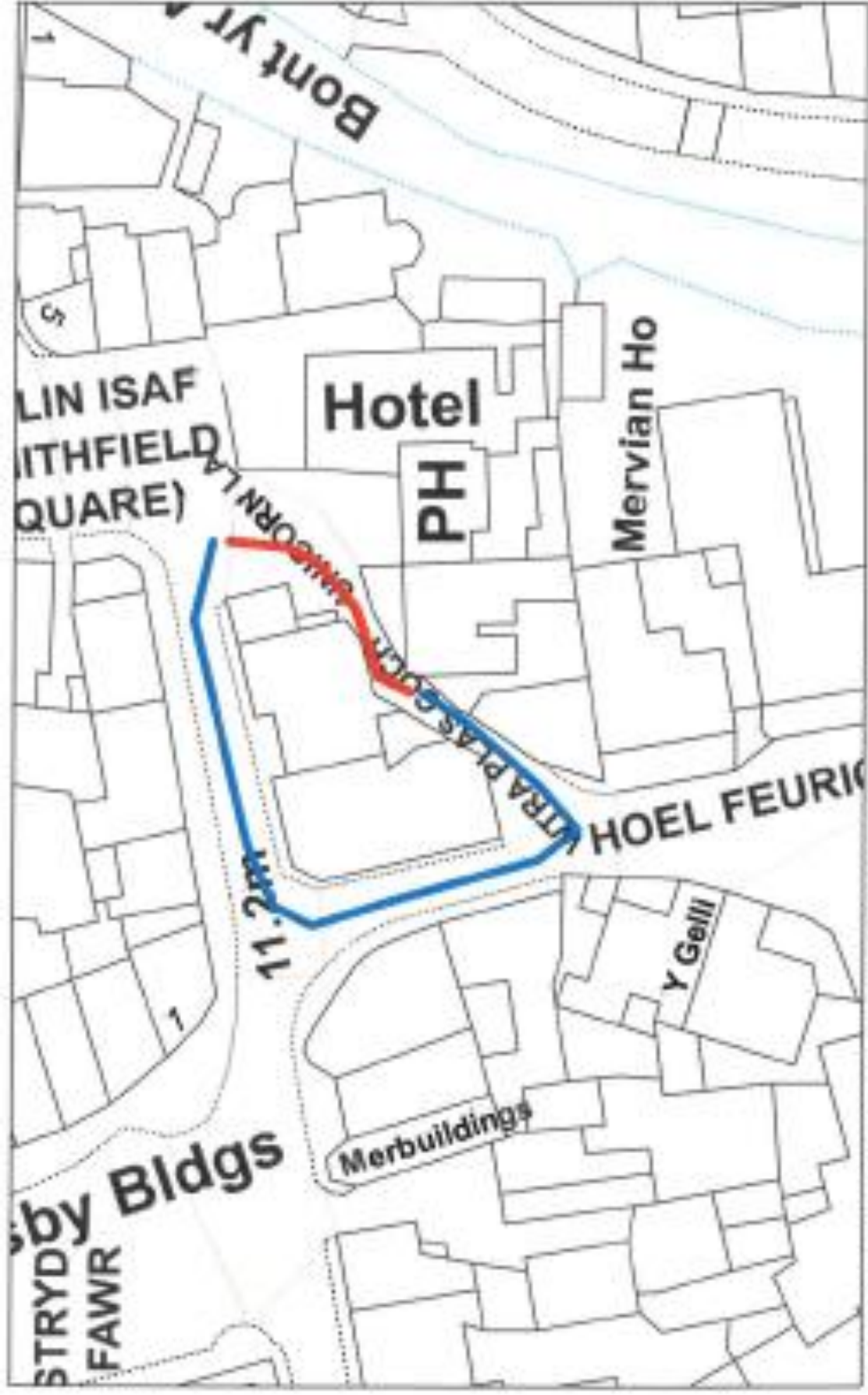
