REMEMBER: In all hospitality premises, licensed and non-licensed, it is mandatory to collect contact information for all staff and adults (over 18) customers or visitors. In the case of a group, it is compulsory to collect details from everyone, not just the person making the booking. To comply, you need to collect names, contact telephone numbers and a record of the date, arrival time, and retain this information securely for 21 days.
