IMPORTANT: February/March 2021 Restrictions grants for businesses liable for Non-Domestic Rates closing at 5:00pm TODAY

The Welsh Government has announced that from 5:00pm today, Thursday, 11 March 2021, no new applications will be accepted for the grants for businesses liable for Non-Domestic Rates, which are administered by Gwynedd Council as part of the February/March 2021 Restrictions Business Funds. - Discretionary grants for small businesses who do not receive a Non-Domestic Rates bill – or are ineligible for the Non-Domestic Rates grants – will remain open for the time being; but don't delay.

Hospitality, Tourism and Leisure businesses Sector Specific Grant application phase 2 closes 8:00pm 12 March 2021

The second phase of the Welsh Government ERF Sector Specific Grant for hospitality, tourism and leisure businesses and associated supply chain

businesses will close at 8:00pm tomorrow, Friday 12 March 2021, or beforehand if funds are fully committed, so don't delay applying. The grant aims to support businesses employing 10 or more staff who expect to lose more than 60% of their turnover as a result of the on-going Alert Level 4 restrictions between 25 January 2021 to 31 March 2021 to meet their operating costs. Written Statement: Covid-19 and Non-Domestic Rates Relief for Businesses in 2021-22

Yesterday 10 March 2021, the Welsh Government confirmed that an additional £380m package of non-domestic rates relief for businesses in sectors most directly affected by the Covid-19 pandemic will be provided. All retail, leisure and hospitality businesses occupying properties with a rateable value of up to £500,000 will receive 100% non-domestic rates relief for the duration of 2021-22. As in 2020-21, local authorities will be responsible for the administration of the scheme. More information about this will be circulated in due course. For the cabinet statement in full, go to:
