## **AGRICULTURE: Avian Influenza – Housing Order to be lifted on 18 April 2023**

The Welsh Government has announced that housing measures for poultry and captive birds are to be lifted today (18 April 2023), but the enhanced biosecurity requirements which were brought in as part of the Avian Influenza Prevention Zone (AIPZ) in December will stay in place. This includes a mandatory biosecurity self-assessment checklist, to be undertaken by all poultry and captive bird keepers, which can be found at:
