URGENT: COVID-19 Economic Resilience Fund Sector Specific Grant closes 12:00pm TOMORROW

The ERF Sector Specific Support Fund, administered by Business Wales, which is targeted at Hospitality, Tourism and Leisure (HTL) businesses and associated supply chain businesses that have been materially affected (greater than 60% impact of turnover) by the restrictions introduced in December 2020, will close at 12:00pm tomorrow, 29 January 2021. Self-Employment Income Support Scheme SEISS

Claims for the third grant of the Self-Employment Income Support Scheme SEISS, for businesses impacted by coronavirus on or after 1 November 2020, must be made on or before 29 January 2021. If you're self-employed or a member of a partnership and have been impacted by coronavirus (COVID-19) you may be eligible to claim the grant. For more information, go to:
