COVID-19: Vigilance required as cases rise

COVID-19 cases are on the rise with the emergence of the BA.4 and BA.5 sub-variants. In response the Welsh Government has confirmed that access to free lateral flow tests (LFTs) will be extended in Wales until 31 July 2022. The announcement can be found at:

Anyone with any of the main symptoms of COVID-19 (a high temperature, a continuous cough or a loss, or change, of taste or smell) should self-isolate and take a LFT test. Information on how to order a LFT kit is available here:

TAX: HMRC update for employers – July payroll NIC thresholds

On 23 March 2022, the UK Government announced that from 6 July 2022 National Insurance thresholds would be increased. To ensure that increased NIC thresholds in July payrolls are accurately reflected, payroll software, including HMRC's Basic PAYE Tools, will need to be updated – this may happen automatically, or action might need to be taken.
