In 2021, Cyngor Gwynedd Regeneration Board agreed to develop a new Regeneration Framework. The intention of the Framework is to ensure that proactive steps are in place to ensure collaboration to improve the areas economically, environmentally, socially and culturally.

As part of that Framework, the county has been divided into 13 Local Regeneration Areas and an action plan has been created for each of the areas. This is the action plan for the Porthmadog and Penrhyndeudraeth Area..

'Regeneration' has been defined as a deliberate effort to improve areas economically, environmentally, socially or culturally. The framework also recognises a key role for communities to identify local priorities; and the contribution of local organisations in developing action plans.

After an engagement process in 2022 and listening to the opinions of local people, the plan includes the vision and priorities of each community for the future. With working in partnership at the core of the arrangements it is hoped that it will provide a clear path to steps that can bring positive change to communities that will change lives for the better. The aim of the plan is therefore to be a guide to investment locally as well as influence on policy decisions in all areas - from health and education to transport and planning.

The Framework for Gwynedd focuses on deliberate efforts to improve areas economically, environmentally, socially and culturally in order to create healthy, prosperous, dynamic and sustainable communities ensuring the input and contribution of a wide range of local organisations.

'OUR AREA' ENGAGEMENT

The aim of the Our Area (Ardal Ni) campaign was to hold a conversation with local communities in order to identify what is important to residents and how they would like to see their area develop over the next 10-15 years



Consultation and engagement with each community has been a key part of drawing up the action plans. There were three stages to the consultation held under the banner of 'Ardal Ni 2035'

- An initial discussion was held with town and community councils together with local organisations, groups and councillors receiving 7 responses on ideas about what should be the local priorities for the area in the period up to 2035. These responses were used as a basis for the second stage of wider engagement with the public.
- A public engagement campaign was organised to give residents the opportunity to voice their opinion regarding the challenges facing their area, what is important to them and what developments they want to see in their area over the next 10 to 15 years . 334 responses were received from the area through an online and paper questionnaire
- Following public sessions, workshops were held with organisations to discuss action plans focusing on the issues and priorities that had been identified locally.

The Porthmadog and Penrhyndeudraeth Area stretches from the coast of Tremadog Bay to the mountains of Snowdonia. The Area includes the communities of Porthmadog, Beddgelert, Cricieth, Dolbenmaen, Llanfrothen and Penrhyndeudraeth.





Porthmadog and Penrhyndeudraeth Area Summary in figures

Strengths

<u>Compares better than the average of Wales or</u> <u>Gwynedd</u>

- **83.8** women's life expectancy, higher than the Welsh figure of 82.3
- **79.1** male life expectancy higher than the Welsh figure of 78.3
- 1.33 (rate per 100) anti-social behavior recorded by the Police which is higher than Gwynedd's figure of 2.52
- 84.1% percentage of adults with a qualification that is higher than the average of Gwynedd (83%) and Wales (80%)
- 80% percentage of the population aged 26-64 who are economically active which is higher than the Welsh figure of 75%
- 69% who can speak Welsh which is higher than the figure for Gwynedd (65%) and Wales (19%)

Weaknesses

<u>Does not compare as well as the average of Wales or</u> <u>Gwynedd</u>

- **13.5%** 4-5 year old children who are obese which is higher than the Welsh average of 11.8%
- **4.02% -** percentage of high value jobs which is lower than Gwynedd (11.1%) and Wales (13.6%)
- **16%** of houses are holiday homes, which is higher than the figures for Wales (3%) and Gwynedd (11%)
- £180,105 median house price in the area which is higher than the Gwynedd average (£167,125)
- **21.9%** percentage of the population living with a long-term illness which is higher than the Gwynedd average of 20.5%

 - Problems relating to parking, road conditions and traffic in many parts of the area (106)
 - Concerns about local health and care provision (104)
 - The public transport network in the area is insufficient (97)
 - Poverty and high living costs are a problem in the area(93)
 - Further action plans to tackle empty houses / properties(89)
 - Lack of projects to develop sustainable energy(86)
