Other issues I have helped to resolve are pavement and access problems in Ffordd Mela, speed hump issues in Talcymerau, fallen trees in Talcymerau, removal of sand on the road along the promenade. I have also tried to resolve dog fouling issues but this is an ongoing challenge in which all councillors must be involved. There have also been issues with the harbour and dredging and I have met with council officers to try to limit the effect of the dredging on nearby residents. I have also been actively involved with the development of the new sailing academy and have been to various meetings to discuss its financing and ongoing building work.</p>
