## Subject:

Disposal of the Council's interest of land located within Penygroes Industrial Estate.

## Recommendation for the Decision:

To dispose the Council's freehold interest in a parcel of land situated within Penygroes Industrial Estate on terms and conditions to be determined by the Head of Housing and Property Department.

## The reason for the need for a Decision:

To enable the Council to dispose of the freehold interest of the parcel of land edged in red on the attached plan, which has no active use, is a burden in terms of maintenance and is surplus to the Council's requirements.

## Rationale and justification for reaching the Decision:

An application has been received by Mr Bryn Roberts to buy a small parcel of land measuring approximately 259m<sup>2</sup> adjacent to the Council's industrial units within Penygroes Industrial Estate from the Council. This site has been unused since the industrial units were developed and Japanese Knotweed is present on the site for which the Council treats at a cost twice a year. The prospective buyer's intention is to

clear the site and create additional storage space in connection to their business Gwynedd Safeflue Specialists Ltd. As the prospective buyer owns an adjoining property, it is considered that the site is more valuable to them rather than any other buyer with this being reflected in the selling price.

Approving the recommendation and disposing of the property directly to Mr Bryn Roberts would enable the Council to proceed without delay to dispose of the property and avoid unnecessary costs in relation to and maintaining the site.

There is no intention to accept less than market value for the property.
