RECOMMENDATION

In accordance with the Adult Care and Support Services Fee Table 2023/24 below, to approve the standard fee for residential and nursing settings in the independent sector, Cyngor Gwynedd's internal residential home fees and non-residential care fees for the financial year 2023/24, and implement them in accordance with the Council's terms and conditions.

REASONS FOR THE DECISION

Background

In accordance with the Rules of Financial Procedure, every Chief Officer is required to conduct a review of all fees charged by their service in accordance with the Council's Fees and Charges Policy. Every Chief Officer should present recommendations to change fee levels, or recommend not to change such charges, in line with inflation on an annual basis.

At the Cabinet meeting on 17 January 2017, Cyngor Gwynedd's Charging Policy for Adults Care and Support Services was approved. The policy confirms the Council's intention to charge a fee for residential/nursing and non-residential services, and then specifies how it will do this.

The unit cost of the different care and support services provided varies and there are

different commissioning arrangements for different services. It should be noted that the prices paid for services commissioned in the independent sector are driven by commercial decisions. Similarly, the actual costs of running the internal services form the basis of the fees charged for internal services.

Under section 59 of the Social Services and Well-being (Wales) Act 2014, a local authority is entitled to charge a fee for care and support services. It is noted that local authorities must "ensure that **no** person must be charged more than it is reasonably practicable for them to pay" and "must not charge a fee that is greater than the cost to the authority in relation to providing or arranging the care and support they receive or arrange themselves through direct payments". In order to set the fee payable by the person who receives the service, the unit cost being paid to the providers is transferred without a reduction. In doing so, the Council ensures compliance with the requirements of the act, i.e. that the persons with the financial means to pay in full for their services do so in full, up to the statutory limit set by the Welsh Government. However, the Council extends the offer for every individual to complete a financial means assessment and the individual's contribution towards the cost of their service will be based on this assessment. Usually, this will mean that a person pays the full fee (unit cost) until they hit a weekly maximum that is determined by their financial means assessment. Then, in these cases, the Council pays the remainder of the weekly cost. Every means assessment is undertaken in accordance with section 63 of the Act and the Care and Support (Charging) (Wales) Regulations 2015.

Explanation/Reasons for the New Fees

Residential and Nursing Services Fees - Independent Sector Homes

The increase in the fees charged on the service users reflects the recommended increase to the fees being paid to the care providers in the independent sector, as follows:

The standard fees that are recommended to be paid to the independent sector providers have been set by following a methodology that was agreed between the providers and the Local Authorities in north Wales. Inflation has been added to the 2022/23 fees to maintain this benchmark, but the fees for dementia care and nursing care remain higher than the regional recommendation to try to address the shortage of dementia and nursing beds in the sector.

The Council always endeavours to commission care at the standard fee. But, with a shortage in supply of certain types of care (for example nursing care), we are increasingly having to commission more placements at higher fees. When individuals

choose care that costs more than the Council's standard fees, we have to pass on these higher fees to the recipients of care when the financial assessment confirms that they can afford to pay in full for their care.

There are also other circumstances where the Council would pay different fees to the standard fees to providers, e.g. when the service user's needs are more intensive or when it is an out-of-county placement. In all such cases, the service user is responsible for paying the full cost for their residential/nursing care but their financial means assessment will determine their contribution.

A full list of the new standard fees that have been set can be found in the table at the end of the decision notice. It will be necessary to approve that the fee paid by the recipients of the service is set at the same level as the cost of arranging and providing the service, and taking into account the assessment of their financial means.

Fees for Residential Services – Cyngor Gwynedd Internal Homes

The standard fee proposed for Cyngor Gwynedd Homes is a direct reflection of the total cost to the Council of providing the service across all internal homes.

As a result of care workers' pay rises following a regrading process, as well as inflation, the actual weekly cost of the provision has risen from £795.90 in 2022/23 to £948.58 in 2023/24. See below details of costs associated with the rise of £152.68:

- £89.78 Increase as a result of salary inflation for 2022/23 and 2023/24
- £16.74 Increase as a result of inflation on other budgets such as electricity and food
- £46.16 The impact of regrading care workers' jobs and raising their salaries

There are currently 243 residents presiding in Cyngor Gwynedd homes and 67 of those individuals have been assessed to be able to pay the full fee (including individuals where the full cost is deferred against the value of their property). Only those with the financial means to pay the full amount will do so, and most people will pay a smaller amount in accordance with an assessment of their financial means.

Fees for Non-residential Services

Maximum Weekly Charge

The Welsh Government has not permitted Local Authorities to increase the maximum weekly charge for non-residential services, and therefore it will remain at its current level of £100 a week for 2023/24.

Home Care/Night Hours Home Care/Assisted Living Accommodation:

Based on a tendering process, a range of different hourly fees are paid by the Council to providers in the independent sector for these services. It is not currently practical for the Council to charge service users a fee based on their care provider. As a result, one standard fee is set across Gwynedd based on the fee paid to the cheapest provider, with a 5% supplement to pay for costs associated with arranging and providing the care.

From 01/04/2023, the standard fee will increase from £20.67 per hour to £22.12 per hour, up to the maximum of £100 per week. Every service user will be offered a

financial means assessment to determine their contribution.

Direct Payments

The hourly unit cost being paid as Direct Payment is being increased from £14.22 per hour to up to £15.22 per hour. The service user's contribution towards the cost of their care is also being increased to up to £15.22 per hour to reflect this increase. Every service user will be offered a financial means assessment to determine their contribution.

Shared Lives Scheme

During 2022/23, the fees were:

- Band 1 £322 per week
- Band 2 £418 per week
- Band 3 £515 per week

Following a review in the context of inflation, the following fees will be payable to the providers from 01/04/2023:

- Band 1 £345 per week
- Band 2 £447 per week
- Band 3 £551 per week

For consistency, it is recommended that the same increases are applied to the fees payable by the recipients of the service. Every service user will be offered a financial means assessment to determine their contribution.

Flat-rate Fees

Telecare

The weekly fee for a basic Telecare package is currently £4.85. There will be a need to increase the weekly fee in line with the cost of inflation to £5.19.

The fee for a telecare service is a 'flat-rate fee' in line with the Social Services and Wellbeing Act (2014). The fee is payable by everyone who applies for the service, and there is no financial means assessment as part of the process.

Food and Refreshments in Day Care

The fee for food and refreshments in day care is currently £4.85 a day, but it will increase in line with the cost of inflation to £5.21 a day. This is also dealt with as a 'flat-rate fee' and consequently, the person who chooses to receive food and refreshments in day care is not entitled to ask for an assessment of his/her financial means before making any payment. This means that everyone who chooses to receive food and refreshments in day care pays the fee.

Impact Assessment

An Equality Impact Assessment has been held in relation to this decision, see Appendix A and the outcome considered in making the decision. It was identified that the decision would impact on older people and people with disabilities. However, every service user continues to receive an assessment of his/her financial means before having to pay most of the fees. This means that no service users will pay more than what they can afford. The purpose of the decision to increase the

standard fees for the services is to reflect the increased inflation occurring in the actual cost of arranging and purchasing/providing the service. No changes are proposed to the constitution or principles of the charging policy.

From the point of view of our duties under the Well-being of Future Generations (Wales) Act 2015, the decision offers a sustainable solution that has been developed in a way that corresponds to the requirements of this act. As stated above, I can confirm that we meet the requirement to ensure that the fee introduced to individuals is not higher than the actual cost of arranging and providing the service.

Decision

Approve the fees listed in the tables below as the fees payable by the recipients of these services (subject to financial means assessment where appropriate) for 2023/24, commencing on 1st April 2023. (The fees may be reviewed during the year if there is a change in the fees paid to the providers).

The Social Services and Well-being Act (Wales) 2014 provides an option for Gwynedd Council to exercise discretion when charging a fee for care services provided. On 17/01/2017, an amended charging policy for residential and non-residential care services was approved by Gwynedd Council's Cabinet.

No changes to the charging policy are being proposed in the Cabinet Member's Decision Notice. In the notice, the Cabinet Member is exercising his duty to review the service's fees annually. The amendments to the fees reflect changes in the actual cost of providing the services to the Council.

6) PARTICIPATION AND CONSULTATION

A consultation was held during 2016 in relation to the changes to the charging policy approved by the Council's Cabinet on 17/01/2017. As no changes to this policy are being proposed, no consultation has been held as part of the equality impact assessment.

In accordance with Financial Procedure Rules, all Chief Officers are required to review all fees charged by their service in line with the Council's Fees and Prices Policy. Every Chief Officer should present recommendations to change fee levels, or recommend not to change such payments in line with inflation on an annual basis.

- There are approximately 1,100 Telecare service users. Older people and disabled people make-up the highest percentage of telecare service users.

10) ADDRESSING THE IMPACT

Disabled people and older people make up the majority of care service users, and as such these are the groups most likely to be affected by the proposed changes. However, every service user is entitled to receive an assessment of his/her financial means before making any payment. This means that their ability to pay is assessed in accordance with the policy, and consequently no one pays more than what they can afford.

b) What steps can be taken to reduce or improve these impacts?

The guidance set by the Government, which has been adopted in the Council's Charging Policy, ensures that the financial means of each service user is assessed before he/she is required to contribute towards the cost of their care. This ensures that the charging system is as fair as possible and ensures that it does not have a substantial detrimental impact on any individual or group.

The Council could choose not to use the discretion to charge/increase contributions, but this would likely lead to cuts to some front line care services. This could have an impact on the Council's ability to provide some services, and as such could be more detrimental to some service users.

c) Is there a need to reconsider the plan?

The decision to increase fees is based on an increase in the actual cost of the provision. There is no need to reconsider the decision.
