RHESYMAU DROS Y PENDERFYNIAD/REASONS FOR THE DECISION

Gwnaed adolygiad cyflawn o ffioedd Rheolaeth Adeiladu gan ddilyn canllawiau CIPFA er mwyn sicrhau bod y ffioedd yn ddigonol i adfer cost y gwasanaeth. O ganlyniad, mae ffi yr awr wedi gostwng o £56.50 i £54.50.

Mae newidiadau mân wedi cael eu cyflwyno i dablau Costau Rheolaeth Adeiladu. Mae hyn i sicrhau bod yr oriau a ddyrannwyd yn erbyn gwaith penodol, yn cael ei safoni rhwng Awdurdodau Lleol yng Ngogledd Cymru.

A complete review of the Building Control fees has been made, following CIPFA guidelines, to ensure sufficient fees are recovered to cover the cost of the service. As a result, the fee per hour has fallen from £ 56.50 to £ 54.50.

Slight changes have also been introduced to the Building Control Charges tables. This is to ensure that hours allocated against specific work, is standardised between Local Authorities in North Wales.


