## Recommendation for the Decision:

Approve the Play Sufficiency Assessment completed by Gwynedd Council to be submitted to the Welsh Government, in accordance to Section 11 of the Children and Families Measure (Wales) 2010.

### Reason why Decision is needed:

Assessing the sufficiency of play opportunities for children is a statutory duty place upon each local authority under Section 11 of the Children and Families Measure (Wales) 2010.

In accordance to the "Play Sufficiency Assessment (Wales) Regulations", November 2012 where it state that every local authority must undertake a play assessment every three years, and submitt an annual action plan to the Welsh Government.

A consultation was undertaken during October - December 2018 in support of this year's assessment. Questionnaires were distributed to every town and community counil, to 'play' providers across each sector, and to other strategic partners. Children, young people and their families' opinions were gathered via a separate questionnaire. In addition specific information was gathered from various departments in respect to play within the context of planning, education, municipal and highways.

The 2019 Play Sufficiency Assessment is attached, along with the 2019-20 Action Plan.
