Subject: Cyngor Gwynedd's votes in the Bangor Business Improvement District ballot

Recommendation for the Decision:

Withold all the votes that Cyngor Gwynedd has in the Bangor Business Improvement District (BID) ballot to ensure that the result of the vote reflects the views of the business community.

Reason why Decision is needed:

The Bangor BID vote will close on 27th November 2025.

Reason and justification behind the Decision:

Following a successful vote in 2021, a second term of the Bangor Business Improvement District commenced. The Bangor BID company continued to operate the BID. In accordance with the Business Improvement Area (Wales) Regulations 2005, a BID is only active for a period of 5 years and a ballot must be held to determine a new term. The current BID at Bangor will come to an end on 31st March 2026.

At a Cabinet meeting on 16th September 2025 support was given to the proposal received from Bangor BID and to hold a vote for a third term for the Bangor Business Improvement District (BID). During this meeting the power was delegated to the Economy and Community Cabinet Member to have responsibility for voting on behalf of Cyngor Gwynedd. The votes will close on 27th November 2025.

The Council has a dual role within Business Improvement Areas, While the Council collects the levy on behalf of the BID company, it is also a non-domestic taxpayer in the city.

Cyngor Gwynedd, as a taxpayer of non-domestic taxes, has a vote for each of their hereditaments. In Bangor, Cyngor Gwynedd's property is a mixture of car parks,

a library, halls and public toilets. These are all included within the proposed BID.

If the BID continues, the Council will have to pay the additional levy for non-domestic properties owned by the Council within the boundaries of the BID e.g. based on a levy of 1.5%. It is anticipated that there would be an additional cost of approximately £2,006 per year in Bangor.

Business Improvement Districts are recognised as a local regeneration vehicle that responds directly to the economic and environmental challenges of town centre business communities. There is support at a national level for the model from the Welsh Government.

In practice, the principle of establishing a Business Improvement District in a town can create a rift within the business community and there are mixed opinions about how effective they are as a means of regeneration. This, along with receiving Elected Members' feedback and opinions on the BID, were important considerations in reaching this decision.

Since its establishment, the Department of Economy and Community has been working closely with the Business Improvement District in Bangor in a supporting role.
