PENDERFYNIAD/DECISION

Cymeradwyo rhestr o ffioedd ar gyfer y gwasanaeth claddu, amlosgfa, toiledau cyhoeddus, Pont Abermaw, gwasanaethau stryd, fflyd a gwastraff masnachol.

Approve a schedule of fees for the burial, crematorium, public conveniences, Barmouth Bridge, streetscene, fleet and commercial waste services

RHESYMAU DROS Y PENDERFYNIAD/REASONS FOR THE DECISION

Gorfodaeth Stryd

Mae lefel dirwyon Gorfodaeth Stryd yn seiliedig ar ddeddfwriaeth/canllawiau cenedlaethol gyda rhai ohonynt yn sefydlog. Mae'r ddirwy Gorchmynion Rheoli Cŵn yn uwch oherwydd polisi'r Cyngor (£100/£60), ond yn dal o fewn y canllawiau. Nid oes bwriad i newid y ffioedd ar gyfer 2015/16. Bydd adolygiad mwy manwl yn cael ei wneud ar gyfer 2016/17 yn dilyn y ddeddfwriaeth wrthgymdeithasol newydd.

Amlosgfa a Mynwentydd

Mae ffioedd yr amlosgfa a mynwentydd wedi eu cynyddu i ystyried chwyddiant. Yn ogystal, gan fod cyfraniad o incwm yr Amlosgfa a Mynwentydd yn rhan o gynllun arbedion ariannol yr Adran, mae ffi arfaethedig am amlosgi oedolyn wedi ei godi ymhellach i gynhyrchu'r cyfanswm disgwyliedig o £14,000 a ffi hawl claddu cyfyngedig wedi ei godi i gynhyrchu £32,000 o incwm ychwanegol.

Pont Abermaw

Mae ffioedd Pont Abermaw o dan adolygiad ar hyn o bryd a bydd y gwasanaeth yn adrodd ymhellach ar y sefyllfa maes o law.

Gwastraff Masnachol

Mae newidiadau sylweddol yn ffioedd Gwastraff Masnachol ar gyfer 2015-16. Yn y gorffennol, mae'r gwasanaeth wedi ysgwyddo costau casgliadau ailgylchu a bwyd er hybu busnesau i ailgylchu mwy. Mae Rheoliadau Gwastraff (Cymru a Lloegr) 2011 diwygiedig wedi dod i rym ar 1af Ionawr 2015 sy'n rhoi gorfodaeth ar gwmnïau/sefydliadau i sicrhau bod yr ailgylchu o'r safon uchaf yn cael ei gario allan. Mae hyn yn golygu bod angen i fusnesau ddidoli eu gwastraff yn gyfan gwbl i wastraff gweddilliol a deunyddiau ailgylchu. Bydd pob cwmni sy'n casglu o fusnesau yn gorfod cadw at y rheolau yma o hyn ymlaen. O ganlyniad, mae'n amserol bod y Cyngor yn codi ffi deg am y gwasanaeth. Mae'r ffioedd wedi eu strwythuro i gadw'r ffi casgliadau ailgylchu mor isel â phosibl ond yn cynyddu ffi casgliadau gweddilliol yn sylweddol er mwyn parhau i roi pwysau ar fusnesau i ailgylchu.

Streetscene

The level of Streetscene fines are based on national legislation/guidelines with some fines being fixed. The fine for Dog Control Orders is on the high side due to the Council's policy (£100/£60), but is still within the guidelines. There is no intention to change the fees for 2015/16. A detailed review will take place in 2016/17 following the new anti-social legislation.

Crematorium and Cemeteries

The crematorium fees have been increased to reflect inflation. As the Crematorium and Cemeteries income is part of the Department's savings scheme, the proposed fee for an adult cremation has been further increased to generate the expected sum of £14,000 and the purchase of burial rights increased to generate £32,000 additional income.

Barmouth Bridge

Barmouth Bridge fees are under review at this moment in time and the service will report further on the situation in due course.

Commercial Waste

There is a significant change in the fees for commercial waste for the year 2015-16. In the past the service has covered part of the cost for the collection of recyclates and food waste collection in order to encourage businesses to recycle more. Separate Waste Collection Requirements – Waste (England and Wales) Regulations 2011 as amended came into force on the 1st of January 2015 which imposes a new minimum level on companies/organisation to ensure that high quality recycling is undertaken. This requires companies/organisation to segregate their residual and recycling material. Every company which collects commercial waste must now provide a separate collection service. As a result, it is timely that Gwynedd Council ensures that a reasonable fee is paid for this service. The fee structure has been developed to ensure that the recycling fee is kept low while the residual fee is much higher which will also encourage more recycling.

YSTYRIAETHAU PERTHNASOL/ RELEVANT CONSIDERATIONS

Mae ffioedd arfaethedig yr Amlosgfa ar gyfer 2015/16 o'i gymharu â ffioedd cyfatebol amlosgfeydd eraill yng Ngogledd Cymru yn parhau i fod yn gymharol a rhesymol.

Er gwaethaf y cynnydd sylweddol, mae'r ffioedd arfaethedig ar gyfer ein mynwentydd yn 2015/16 yn parhau tua ffigwr cyfartaledd siroedd eraill yng Nghymru. Bydd y codiad yn y ffioedd yn cynyddu canran o wariant y Cyngor ar fynwentydd i'w ariannu gan yr incwm o ffioedd o 31% i ymron i 34%. Mae hyn yn deillio o'r bwriad tymor hir i leihau costau i'r trethdalwr am y gwasanaeth mynwentydd.

Er bod ffioedd arfaethedig Gwastraff Masnachol wedi codi'n sylweddol, maent yn dal yn cymharu'n ffafriol gyda ffioedd Cynghorau eraill o ran casglu gwastraff gweddilliol ac yn y chwartel isaf gyda chasgliadau ailgylchu.

The proposed crematorium fees for 2015/16 continue to be comparable and reasonable when compared with fees charged at other crematoria in North Wales.

Despite the substantial increase, the proposed burial service fees for 2015/16 continue to be around average when compared to those charged by other authorities in Wales. The rise in fees will increase the percentage of the Council's expenditure on its cemeteries that is financed by income from the fees from 31% to nearly 34%. This comes from the long term intention of reducing costs of the cemetery service for the ratepayer.

Despite the significant increase in Commercial Waste fees, they compare well with fees set by other authorities for the collection of residual waste and are in the lower quartile for the collection of recyclates.

Mewn rhai achosion bydd y codiad mewn ffioedd yn cynyddu incwm ymhellach, er mwyn cyfrannu tuag at dargedau arbedion cytunedig a chost gwasanaethau cyfredol. Eithriadau i'r sefyllfa gyffredinol nodwyd uchod yw Gorfodaeth Stryd (sy'n destun adolygiad llawn yn 2015/16) a Phont Abermaw (lle mae trafodaethau'n parhau am ei dyfodol).

I support the fees that are recommended here for 2015/16 and I'm satisfied that they are at least sufficient to meet with inflation. In some instances the rise in fees will increase income further, in order to contribute towards agreed savings targets and the cost of existing services. Exceptions to the general situation noted above are Streetscene (which is subject to a full review in 2015/16) and Barmouth Bridge (where discussions continue about its future).
