### RHESYMAU DROS Y PENDERFYNIAD/REASONS FOR THE DECISION

Ar ddechrau tymor bob Cyngor mae gofyn enwebu aelodau i gynrychioli Cyngor  
Gwynedd ar restr o gyrff allanol.

Mae'r Cynghorydd Sian Gwenllian a fu'n cynrychioli'r Cyngor ar Cartrefi Cymunedol  
Gwynedd ers 30 Mehefin 2014 wedi penderfynu ymddiswyddo, ac ar 13 Ionawr 2015  
penderfyniad Arweinydd y Cyngor Dyfed Edwards oedd enwebu'r Cynghorydd Ioan  
Thomas i gymryd ei lle.

Yn dilyn newidiadau i gyfrifoldebau Aelodau Cabinet Cyngor Gwynedd, a chyn iddo  
ddechrau gweithredu fel Cyfarwyddwr Cartrefi Cymunedol Gwynedd, daeth yn amlwg  
y byddai gwrthdaro rhwng cyfrifoldebau'r Cynghorydd Ioan Thomas fel Aelod Cabinet  
gyda Chyfrifoldeb am Dai â swydd Cyfarwyddwr Cartrefi Cymunedol Gwynedd.

I sicrhau tryloywder mae'r Cynghorydd Ioan Thomas yn enwebu'r Cynghorydd John  
Wyn Williams i gymryd sedd y Cynghorydd Siân Gwenllian.

*At the start of every Council term it is required to nominate members to represent  
Gwynedd Council on a list of outside bodies.*

*Councillor Sian Gwenllian who has represented Gwynedd Council on Cartrefi  
Cymunedol Gwynedd since 30 June 2014 has decided to resign, and on 13<sup>th</sup> January  
2015 the Council Leader Dyfed Edwards decided to nominate Councillor Ioan  
Thomas to take her place.*

*Following changes in the responsibilities of Gwynedd Council Cabinet Members, and  
before he had started in his role as a Director of Cartrefi Cymunedol Gwynedd, it had  
become apparent that there would be conflict between Councillor Ioan Thomas'  
responsibilities as Cabinet Member with responsibility for Housing and the role of a  
Director of Cartrefi Cymuned Gwynedd.*

*In order to ensure transparency, Councillor Ioan Thomas has nominated Councillor  
John Wyn Williams to replace Councillor Siân Gwenllian.*
