- *Keep some issues at the forefront of the Council's work although there is no councillor or committee responsible for them*
- *Assist a Cabinet Member with his/her portfolio by maintaining contact between special interest groups and the Cabinet and bringing specialist information to the Cabinet Member.*

*Cllr. Annwen Daniels has a great interest and enthusiasm for the field – she is a foster parent to three children, a school governor and Chair of the Cae*
