**PENDERFYNIAD/DECISION**

**RHESYMAU DROS Y PENDERFYNIAD/ REASONS FOR THE DECISION**

*O fewn Cyngor Gwynedd mae'n rhan o rôl y Cyfarwyddwr Statudol Gwasanaethau Cymdeithasol i gymryd cyfrifoldeb ariannol dros ddefnyddwyr gwasanaeth sydd heb capasiti feddylol i weithredu'n ariannol dros eu hunain. Fel arfer mae'r defnyddwyr yma heb deulu na ffrindiau sy'n gallu cynorthwyo. Mae'r rôl yn cynnwys gweithredu fel Apwyntydd ar fudd-daliadau'r Defnyddiwr Gwasanaeth neu fel Dirprwy Cyllid ac Eiddo trwy'r Llys Gwarchod.*

*Yn 2014 penderfynodd y Cyfarwyddwr Statudol Gwasanaethau Cymdeithasol i ddirprwyo'r rôl i Bennaeth Adran Oedolion, Iechyd a Llesiant.*

*Mae'r gwaith o ddydd i ddydd yn cael ei wneud gan Uned Rheoli Asedau Defnyddwyr Gwasanaeth o fewn yr Adran Oedolion, Iechyd a Llesiant. Ar hyn o bryd mae'r Uned yn gweithredu ar ran 251 o ddefnyddwyr gwasanaeth.*

*Mae gan yr Uned targed incwm blynyddol o £94,840 ond mae gallu'r Uned i gasglu incwm yn ddibynnol ar allu'r defnyddwyr i dalu ac ar lefel ffioedd sy'n cael eu gosod gan y Llys Gwarchod.*

*Yn ychwanegol i'r ffioedd â osodir gan y Llys Gwarchod mae gan yr Uned hawl i godi ffioedd am eu gwasanaeth. Ar ôl holi Cyngorau eraill gwelwyd eu bod yn codi ffi ychwanegol am weinyddu ystadau defnyddwyr gwasanaeth ar ôl iddynt farw. Roedd y ffi a godir yn amrywio o Gyngor i Gyngor. Fel arfer codir ffi rhwng £150 a £350 fesul achos.*

*Er mwyn uchafu incwm yr Uned gofynnir am ganiatâd i godi ffi o £250 (heb TAW) ar gyfer*

*pob achos o farwolaeth. Amcangyfrif y byddai hyn yn denu tua £4,000 o incwm ychwanegol pob blwyddyn.*

*Bydd y ffi o £250 yn cynnwys gwaith hysbysu asiantaeth berthnasol am y farwolaeth a pharatoi gwybodaeth ariannol i weinyddwr y stad neu gyfeirio at Gyfreithiwr y Trysorlys a hefyd sicrhau gwaredu asedau yn ddiogel e.e. tŷ, dodrefn, gemwaith a.y.b.*

*Bydd casglu'r ffi yn ddibynnol ar allu ystâd i dalu h.y. os oes digon o arian yng nghyfrif y defnyddiwr gwasanaeth ar ôl talu dyledion.*

*Within Gwynedd Council it is part of the role of the Statutory Director of Social Services to take financial responsibility for service users who do not have the mental capacity to act for themselves in financial matters. Usually such a service user has no family or friends who can assist. The role involves operating as Appointee on the Service User's benefits or as Finance and Property Deputy through the Court of Protection.*

*In 2014 the Statutory Director of Social Services decided to delegate the role to the Head of Department of Adults, Health and Well-Being.*

*The day to day work is carried out by the Service User Finance and Asset Management Unit within the Department of Adults, Health and Well-Being. Currently the unit is operating on behalf of 251 service users.*

*The unit has a target annual income of £ 94,840 but the ability of the unit to gather income is dependent on the ability of users to pay and the level of fees that are set by the Court of Protection*

*In addition to the fees imposed by the Court of Protection the Unit has the right to charge fees for its services. After questioning other Councils it was found that they made an additional charge for the administration of service users' estates after they died. The fee charged varied from Council to Council but was usually between £150 and £350 per case.*

*In order to maximize its income, the Unit requests permission to charge a fee of £250 (excluding VAT) for the administration of each instance of death. It is estimated that this would generate about £4,000 in extra income each year.*

*The fee of £250 will include informing relevant agencies of the death and the preparation of financial information to the estate administrator or referring to the Treasury Solicitor and also ensuring the safe disposal of assets such as house, furniture, jewellery etc.*

*The collection of the fee is dependent on the ability of the estate to pay. i.e. if there are sufficient funds in the service user's account after settling all liabilities.*
