Yn 2010, cychwynnwyd codi ffi am wasanaethau cyfieithu ar y pryd, cyfieithu ysgrifenedig a phrawf ddarllen ar bartneriaethau, cyd-bwyllgorau, fforymau ayyb sy'n derbyn gwasanaeth cyfieithu gan y Cyngor.

Gosodwyd targed incwm ar gyfer yr Uned Gyfieithu, fyddai'n fodd o gynorthwyo'r Cyngor i gwrdd â'r bwloch ariannol; a chytunwyd i adolygu'r ffioedd yn flynyddol.

Mae cryn waith wedi ei gyflawni ar y ffioedd a godir am y gwasanaeth cyfieithu er mwyn sicrhau fod y ffioedd yn adlewyrchu gwir gost y gwasanaeth cyfieithu, tra'n parhau i fod yn gystadleuol. Mae'r ffioedd am wasanaeth yr Uned Gyfieithu yn gyffredinol is na'r hyn a godir gan gyfieithwyr llawrydd.

Nid yw ffioedd yr Uned Gyfieithu wedi cynyddu ers 2012/13. Felly, bydd ffioedd newydd am wasanaethau yr Uned Gyfieithu yn weithredol o 1 Ebrill 2015.

*Much work has been undertaken on the fees for the translation service in order to ensure that they reflect the true cost of the translation service, while remaining competitive. Generally, the translation service fees are lower than those charged by independent translators.*

*The fees of the Translation Unit have not increased since 2012/13. Therefore the new fees for the services of the Translation Unit will be implemented from 1 April 2015.*
