Why the need for a decision

Following a successful vote back in 2015, the Caernarfon Business Improvement District was established in April 2016. The HWB Caernarfon company was established to implement the BID. In accordance with The Business Improvement District (Wales) Regulations 2005, the BID can only been operational for a five year period and it is required to follow a similar process again for another term. The current situation is that the Caernarfon BID term will end on 31 March 2021.

At the Cabinet meeting on 15 December 2020, it was resolved to support holding a vote on the proposals received from HWB Caernarfon for a second term of the Business Improvement District (BID). During that meeting, it was resolved to delegate power to the Cabinet Member for Economy and Community to take responsibility for voting on behalf of Gwynedd Council. The votes will close on 4 March in Caernarfon.

The Council has a dual role within the Business Improvement Districts. While the Council collects the levy, it is also a non-domestic ratepayer in the town.

Gwynedd Council, as a non-domestic ratepayer, has a vote for each of its properties. In Caernarfon, the Gwynedd Council properties include offices, car parks and miscellaneous property. These are all included within the proposed BID.

If a BID is established, the Council would have to pay the additional levy for a non-domestic property in Council ownership within the BID boundaries e.g. based on a levy of 1.5%, it is anticipated that there would be an additional cost of approximately £12,827.25 per annum in Caernarfon.

Business Improvement Districts are acknowledged as a local regeneration vehicle that respond directly to the economic and environmental challenges of town centre businesses. Welsh Government is very supportive of this model of working and has supported Local Authorities over the past years to establish and support them. Welsh Government considers them to be a key part of the regeneration process in the context of their Regeneration Investment Programmes.

The Council's Economy and Community Department will also support Business Improvement Districts as an organisation that has the ability to drive the regeneration agenda within towns, triggering local economic developments. The investment made by businesses by paying the levy ensures that important issues within the business community can be addressed and that local ownership is taken of the efforts made to make Caernarfon a more prosperous place.
