RHESYMAU DROS Y PENDERFYNIAD/REASONS FOR THE DECISION

Yn dilyn penodi'r cyn-Bencampwraig Llais Plant a Phobl Ifanc, y Cyng. Mair Rowlands yn Aelod Cabinet Hamdden a Phlant a Phobl ifanc, penderfynwyd yn awr benodi'r Cyng. Gethin Glyn Williams yn bencampwr Llais Plant Phobl Ifanc Cyngor Gwynedd yn ei lle oherwydd ei fod yn awyddus i ymgysylltu gyda phlant a phobl ifanc y sir a datblygu'r rôl ymhellach.

Mae'r aelod yn Llywodraethwr ar ysgol gynradd ac ysgol uwchradd. Mae'n aelod o'r pwyllgor lleol (Cyfeillion Parc Coffa Abermaw) sydd wedi llwyddo i ddenu grantiau i ail wampio cyrtiau tennis a rhoi ardal chwaraeon aml-ddefnydd yn ei le yn y Bermo er mwyn i bobol ifanc y dre gael cyfle i fwynhau chwaraeon.

Mae hefyd yn aelod o Banel Adolygu Dalgylch Y Gader sydd wedi bod yn trafod cynigion i ad-drefnu addysg yr ardal.

Following the appointment of the previous Voice of Children and Young People's Champion, Coun. Mair Rowlands as Cabinet Member for Leisure and Children and Young People, it was decided to appoint Cllr Gethin Glyn Williams as Gwynedd Council's Voice of Children and Young People's Champion to take her place as he is eager to engage with the children and young people of the county and to further develop the role.

He is a Governor of one primary school and one secondary school. He is a member of the local committee (Friends of the Barmouth Remembrance Park) which has attracted grants to revamp the tennis courts and provide a multi use games area in Barmouth for the young people of the town to enjoy.

He is also a member of the Y Gader Catchment Area Review Panel, the panel responsible for discussing the options regarding the provision of education in the area.
