Recommendation for the Decision:

To appoint Councillor Dilwyn Morgan as the Older People's Champion for the term of this Council until the end of April 2027.

To appoint Councillor Angela Russell as the Countryside and Environment Champion for the term of this Council until the end of April 2027.

Reason why Decision is needed:

Appointing an Older People's Champion is a statutory requirement.

Several councils have appointed councillors as champions in different areas of work. From time to time a request from different interest groups to the council requests that the Council nominates one of its members as a champion of their particular interest.

The purpose of having champions is:

- 1. To represent groups that would otherwise not be fully represented
- 2. To keep issues at the forefront of the Council's work even though no Councillor or committee is responsible for them.
- 3. To maintain contact with the Cabinet and bring specialist information to the Cabinet Members.

These are the only two champions that will be appointed by the Council for the period 2022 until April 2027.

Reason and justification behind the Decision:

Councillor Dilwyn Morgan is appointed as Older People's Champion to promote this area because of his interest and experience as the Cabinet Member for Adults, Health and Well-being.

Councillor Angela Russell is appointed Countryside and Environment Champion to promote this area because of her interest and previous experience as a Champion in this field.
