PURCHASE LAND TO FACILITATE IMPROVEMENT TO THE A493 BETWEEN PENNAL AND ABERDYFI

PENDERFYNIAD/DECISION

Bod llain o dir yn cael ei brynu ar delerau ac amodau i'w penderfynu gan reolwr eiddo corfforaethol ar gyfer Ledu ac ail linio llain o'r ffordd. Bydd gwerth y tir yn ddibynnol ar bris y farchnad. Fe fyddai'r pryniant yn disgyn o fewn y grymoedd sydd wedi eu dirprwyo i'r Aelod Cabinet.

That a strip of land be purchased on terms and conditions to be determined by the Corporate Property Manager for the purpose of widening and strengthening the road. The value of the land will depend on market value but within the powers delegated to the Cabinet Member.

RHESYMAU DROS Y PENDERFYNIAD/REASONS FOR THE DECISION

Mae rhan o'r ffordd A493, rhwng yr eiddo a adweinir fel Bontbren a Nantygwenlli ger Pennal, yn droelliog gyda nifer o fynediadau prifat.

Y bwriad yw i ail linio llain y ffordd i greu lon llawer fwy ddiogel i gerbydau yn ogystal a creu ffordd cymunedol i gerddwyr neu cerbydau di-fodur.

Yn y flwyddyn ariannol hon (2014-15) mae cyllid wedi'i neilltuo tuag at y cynllun gan y gronfa cludiant lleol.

The section of the A493 road, between the properties known as Bontbren and Nantygwenlli near Pennal is winding with numerous private entrances.

The intention is re-align the road to create a safer carriageway for motorist as well as create a community route for pedestrians and non motorised vehicles.

In this financial year (2014 -15) funding has been allocated towards this scheme from the Local Transport fund.
