## **Recommendation for the Decision:**

**Centre of Sign-Sight-Sound** - to appoint Councillor Huw Wyn Jones following the resignation of Councillor Sian Hughes from the Council

Wales Council for the Blind - to appoint Councillor Huw Wyn Jones following the resignation of Councillor Sian Hughes from the Council

**Abbey Road Centre, Bangor, Management Committee** - to appoint Councillor Paul Rawlinson following the resignation of Councillor W Roy Owen

**Cambrian Railway Liaison Committee** - to appoint Councillor Louise Hughes following the resignation of Councillor Gethin Glyn Williams

HWB Caernarfon - to appoint Councillor Ioan Thomas as an observer only

**Caernarfon Harbout Trust** – to appoint Councillor Cai Larsen for a period of three years from 1 November 2019.

## Reason why the Decision is needed:

At the beginning of each Council term, member nominations are required to represent Gwynedd Council on a list of outside bodies. The final decision on these

appointments are held in the hands of the Executive. This was done by asking for declarations of interest by members, consulting with Group Leaders and the Council's Cabinet Members and, where relevant, based on political balance appointed by the Full Council. In a few cases, the representation has also been established in the constitution of the body be appointed to and derive from a role that the member has, such as the cabinet member for the specific field. This report updates the list.

#### **Police and Crime Panel**

A member is nominated to represent Gwynedd Council on the Police and Crime Panel on the basis of regional political balance. I am satisfied that the member nominated meets the requirements for nomination.

#### Caernarfon Harbour Trust

The Caernarfon Harbour Trust (Constitution) Amendment Order 2012 requires the appointment of a new trustee at the end of a predecessor's term for a fixed period of 3 years. This means that the appointment will extend beyond the term of the current Council. I am satisfied that the nominated member meets the requirements.

## The Reasoning and Justification for reaching the Decision:

The recommendations reflect the outcome of the processes highlighted above and represent appropriate appointments to the listed bodies.
