# **Care Scrutiny Committee**

### LEARNING DISABILITIES SERVICE.

In September 2018, a report and action plan by the Cabinet Member for Adults, Health and Well-being, were considered following the inspection by the Care and Social Services Inspectorate Wales and Healthcare Inspectorate Wales of the Gwynedd Learning Disabilities Service.

### Matters raised by Members of the Scrutiny Committee

- It was suggested that a more detailed look at the figures should be undertaken as well as an analysis of the reasons for refusing applications for assistance and support.
- Whilst being grateful for the additional work undertaken by some members of staff, the Cabinet Member was asked to consider if this was sustainable and to discuss this with third sector groups.
- Concerns were noted regarding the backlog of Deprivation of Liberty Safeguards( DoLS) assessments. The Head agreed to bring information to the Chair regarding progress in this respect.
- The Department was asked to share information with the Committee about the multi-disciplinary Transformation Group.

The work that had been carried out over the past two and a half years in an attempt to address the recommendations in the service review was welcomed. The Committee was convinced that the service was proceeding in the right direction but, at the same time, it acknowledged that much work was still required.

### **COMPLAINTS ANNUAL REPORT— ADULTS (2017-18)**

In June 2018 the Annual Complaints Report (Adults) for 2017-18 was considered.

# Main points from the discussion:

- The examples of letters of thanks within the report, which were extremely heartening, were welcomed.
- An assurance was given by the Cabinet Member that the Department took every complaint seriously and sought to resolve any problems promptly.
- It was suggested that it would be useful to note a target date for action in the "lessons to be learnt" log rather than to note 'as soon as possible' whilst stating the reason if there was any failure to act within the timetable.
- It was explained that it was difficult to gather statistics and data as a great deal
  of the complaints were presented informally and were resolved immediately by
  the relevant teams.
- A concern was noted regarding the lack of carers especially in Dwyfor and Meirionnydd and that this added to the number of complaints.

Resolved: To accept, note and give thanks for the report and positive responses, and to submit these to the Cabinet Member as part of his report to the Cabinet.

# **Homelessness**

In September 2018, a report was submitted by the Cabinet Member for Housing, Leisure and Culture noting that Gwynedd Council had carried out a Strategic Review of Homelessness in accordance with the requirements of the Housing (Wales) Act (2014). It was reiterated that the findings of the review set a foundation for developing a Homelessness Strategy and that the Housing Service was currently in consultation on local actions that would address the aims and requirements of the Strategy.

Reference was made to the executive summary included with the report that provided a detailed analysis of the levels and nature of homelessness, an audit of the services and review of the resources available to address homelessness in the County. It was reiterated that the executive summary provided evidence for the North Wales Regional Homelessness Strategy alongside the Gwynedd Local Homelessness Provision Action Plan.

During the Committee's discussion, the following points were made by Members:

- The private sector provision needed to be considered - the need to ensure that the standard of the houses met the statutory requirements
- The review conveyed the problems but did not offer solutions
- It was necessary to bring more empty housing back into use
- Wylfa needed to collaborate with Isle of Anglesey in an attempt to identify elements that would have an effect
- There was a need to share good practice with other Councils
- A suggestion to review the points system the current system did not reflect the desperate situation of individuals / families
- Had the emergence of AirBnB reduced the number of properties available for homes?
- Suggestion to create a list of available provision for the homeless according to area
- Was it possible for the Council to establish an arm's length company to provide social housing?

The Cabinet Member stated that a review of the points system was under way and that there would be an opportunity to consult on the proposals. It was also highlighted that the Housing Strategy would soon be introduced and that this would identify specific areas to be addressed. This would provide an opportunity to consider alternative and creative ideas.

### Resolved:

- To accept the information
- To congratulate the Service for making it on to the 'Cymorth Cymru' shortlist
- To ask the Cabinet Member to address Members' observations in drawing up the Housing Strategy



# **Autism**

In September 2018, the reports of the Cabinet Member for Adults, Health and Well-being, the Cabinet Member for Children and Families, and the Cabinet Member for Education were submitted.

## Members' Observations

- That it was necessary to place more emphasis on supporting people before they get isolated and that early intervention saved money in the long term.
- To consider appointing a coordinating officer for autism services.
- That it was necessary to raise the awareness of schools about autism so that interventions can take place at schools where children are low on the spectrum.
- Members' concern regarding the future of the Autism Centre at Ysgol Coed Mawr, Bangor were noted whilst details and an update were requested from the Cabinet Member for Education.
- Concern was expressed regarding the inconsistency of the service and that harmonisation was required across schools.
- A detailed report was requested for the Committee in respect of children who receive out of county education.
- It was emphasised that the post of the Children and Families' Service
  Manager was key within the service; and in order to ensure continuation, a
  plea was made to retain the post following the current post-holder's
  retirement.
- Derwen staff were congratulated and thanked for their excellent work.

The fact was welcomed that there was collaboration between the three Departments and robust developments in terms of collaboration with the Health Board.





# Young People leaving the Council's care



In January 2019, the report of the Cabinet Member for Children and Young People was submitted, providing the Committee with information on young people leaving care.

The Cabinet Member and officers expanded on the content of the report, and also responded to questions / observations from the Members. The following main points were highlighted during the discussion:-

- The success of the service offered to young people between 21 and 25 years old was highlighted through the fact that 38 of the 40 open cases had opted to continue to receive the support.
- The fact that the personal counsellors assisted the young people to claim the financial support available to them was welcomed.
- Support was expressed towards the collaboration arrangements with universities, that now acknowledged the situation of young care-leavers, e.g. through allowing the extension of the duration of their course.
- It was noted that it was evident that the Department's understanding of the young people's development had improved and that they therefore could give them appropriate support at the right time.
- It was suggested that the wording of the service's letter to care-leavers (included in the appendix to the report) was lengthy and complicated, and could be more inclusive. Nevertheless, the difficulty, due to the expectation for the letter to be in-keeping with the report of the Children's Commissioner, was acknowledged.
- The Members were glad to hear that an enthusiastic group of young people and workers were eager to re-establish a Young People Accommodation and Support Group. The intention to engage with these young people through social media was welcomed.
- The importance given to all individuals to achieve their full potential was emphasised and although this was measured by the department, it was not shown in the Government's statistics on looked-after children's GCSE results.

### NORTH WALES ECONOMIC GROWTH PLAN

One of the major developments this year has been the regional work to establish the North Wales Economic Ambition Board. It is an extremely exciting development for the County as well as the region as a whole. The Scrutiny Committee has considered the matter on more than one occasion and has stated:

- That economic benefit will come to Gwynedd as a result of the developments
- That financial risks need to be addressed
- That the Welsh Language has a status at the Joint Committee and is key to all the arrangements
- That the governance arrangements need to be challenged in order to ensure political accountability for regional developments within the Authority.

It was also recommended that Gwynedd Council undertakes the role of the host authority for the development. We are very pleased that the Council has undertaken this responsibility.

Since this is such a crucial development, Committee members were of the opinion that it was key that all Gwynedd councillors should be aware of these developments. Therefore, several sessions were held for all the Members in order to raise awareness and ensure a full understanding of that which the Plan is endeavouring to fulfil.

# **Education in Gwynedd**

# **EDUCATIONAL RESULTS - SUMMER 2018**

The Committee looked at the Summer results across the age ranges. It was reported as follows:

- The significant reduction in the results for English, Key Stage 4 (GCSE) and the change without any notice in the subject's grade boundaries were noted.
- Concern was noted regarding the significant impact on those individuals who had received a qualification in the Summer of 2018 and the Cabinet Member was asked to discuss this with Qualifications Wales to ensure that there would be no changes in grade boundaries, to the same extent, in any subject in the future.
- In addition, Committee members noted the impact this has on our teachers who work hard to try and ensure that our young people succeed.

Furthermore, during the year, attention was given to educational attainment in general, and Members have expressed their frustration with the new reporting requirements on performance and the difficult task we have as Members to scrutinise attainment. The Committee is eager to scrutinise results in order to ensure fair play to all the young people of Gwynedd as well as ensure that appropriate support is given to attain the required quality in each school.







The Committee is also aware that there are far reaching changes afoot in the Education sector. Once again, Committee members were of the view that this was a specific matter that was of interest to all Members. A specific session was held for all Members to receive information about these developments with an opportunity to ask questions to officers of both the Department and GwE about the preparatory work.

# **Reducing Teachers' Workload**

A session was held to scrutinise the work being done to reduce teachers' workload (in particular those leading within our schools). It was noted that good work has already been done to reduce duplication and provide a platform for school leaders to share good practice. Committee Members were glad to see that this work has been done but noted that further work remains in order to reduce the administrative burden on school leaders in future and in recognition that there are consistently more requirements on their time.



# **Language Centres**

The Scrutiny Committee had an opportunity to scrutinise developments within the language centres sector before the matter was discussed by the Cabinet. High praise was given to the work of the centres during the discussion.



# **School Meal Debts**

It came to the attention of the Committee that a considerable debt was accruing in respect of payment for pupils' school meals. This matter was scrutinised and the service was challenged to get to grips with the matter before families faced huge debts that could not be repaid. It was noted that there are measures in place to improve the situation, but there was also a focus on the need to deal with the situation in a sensitive manner and enable families to pay in instalments.

# **Brexit**

2018/19 has been a year where Brexit developments have received considerable attention! The Scrutiny Committee has looked at the possible effect of Brexit in two specific areas, namely:

- the Council's support to small businesses to prepare for Brexit
- Gwynedd Council's preparations in terms of the possible implications of Brexit to services.

Please note - as this is an area where there are consistent changes to the guidance, the observations reflect the situation faced during 2018/19.

A significant part of the support available for businesses is provided on behalf of Welsh authorities by the Welsh Local Government Association. An officer from the Association visited the Council to provide an update to all Members on the guidance available, and an update was given by Council officers on the internal preparations for Brexit.

# **Food Standards Agency Audit**

A report by the Cabinet Member was submitted on the progress made to address 34 recommendations published by the Food Standards Agency (FSA) following an audit of the Council's food law enforcement provision. A report was provided on the progress made to meet the recommendations in accordance with the plan to the Communities Scrutiny Committee, which met on the 10th October 2017.

In February 2018, FSA officers revisited the Service to assess further progress on the improvement plan. It was reported that 20 of the recommendations still required further action.





### **RESOLVED:**

To accept the content of the report of the Cabinet Member for the Environment, and acknowledge that the Council was unable to meet its statutory responsibilities in the field of Food Standards.

Members of the Scrutiny Committee wished to draw the Cabinet Members' attention to their responsibility in this field, and recommended that they contact Welsh Government immediately to request further resources to meet the statutory requirement.

# **Delegation Procedure for Planning Applications**

The Head of the Environment Department submitted a report which responded to concerns regarding the delegation procedure in the context of decisions relating to Plas Pistyll. As part of the report, a detailed account of the application's planning history was noted, along with the current and previous Planning Delegation Schemes in Gwynedd. The Cabinet Member noted that he had commissioned a piece of work to gather information that would respond to the local discontent and the lack of understanding of how the decision had been made, and to identify whether the delegation procedure had been followed properly.

# **Sustainable Drainage Systems**

A report was presented by Gwynedd Consultancy highlighting the implications to the Council and developers from implementing Schedule 3 of the Flood and Water Management Act 2010. In accordance with the Act, new developments would have to contain Sustainable Drainage Systems (SuDS) features that satisfied national standards. It was noted that all Local Authorities were required to establish a body that would accept, approve, adopt and enforce SuDS features, in accordance with the new Regulations - which was the Sustainable Drainage Systems Approval Body (SAB).

During the Committee's discussion, the following points were highlighted:

- Developers were facing increased pressure and costs
- The costs would add to the sale price of houses and it would, therefore, be impossible to provide affordable houses
- This was a further statutory requirement imposed on an Authority without further funding
- There was a need to ensure good and transparent arrangements and to establish a good relationship with developers

# **Smallholdings**

A report was presented by the Senior Property Manager detailing the principles of managing the Council's smallholdings estate. It was noted that a comprehensive review had been held in 2008 to look at the purpose of the estate, its financial performance and the management arrangements. A decade had passed since the review, therefore it was considered timely to revisit the issue and confirm the logic behind the importance of continuing to provide the County's smallholdings.



Following discussions it was resolved to accept the report and to recommend to the Cabinet Member to consider establising one cross-County panel with a clear constitutions, to establishing an arm's length company in the longer term, to retain the temporary staff resource and reinvest in the estate any profit beyond the figure allocated.

# Planning and the Welsh Language

- Planning laws in Wales are complex and sometimes difficult to understand.
- Effective land use planning could contribute to robust economic development, to retaining natural assets and improving the quality of life of individuals and communities.
- National planning policy provides the policy framework for local planning authorities to prepare their Development Plans effectively, and they are supplemented by Technical Advice Notes (TAN) on specific subjects.
- Additionally, local authorities can prepare Supplementary Planning Guidance (SPG) to help ensure that the policies are better understood.
- The Gwynedd and Anglesey Joint Local Development Plan 2011 - 2026, was adopted in July 2017.
- A Scrutiny Investigation was established on 7 December 2017 to contribute to the process of producing the Guidance on Maintaining and Creating Distinctive and Sustainable Communities.
- The Investigation's recommendations were submitted to the Joint Planning Policy Committee on 24 April 2018.

### The recommendations were:

- To hold a public consultation on developments of 10+ houses in urban areas and 5+ houses in rural areas.
- A Language Statement and Language Assessment for each development that is subject to a public consultation.
- Ensure that there is input from external experts on Linguistic Planning, Research, Analysis, Consultation and Engagement.
- The above-mentioned experts to be given an opportunity to contribute to the pre-consultation draft Guidance in order to maximise the value of the consultation.





# Other matters that have received attention from the Communities Scrutiny Committee

**Public Services Board** —To consider the Gwynedd and Anglesey Well-being Plan's Priority Projects

**Waste Enforcement** — Background information was considered and an Investigation was established in 2017. The Investigation continues.

**Public Toilets** — The draft Toilets Strategy was scrutinised and recommendations were made to the Cabinet.

**Crime and Disorder** — the Annual Report of the Crime and Disorder Partnership was considered. The members were happy with the Partnership's work.

Parking Management Arrangements — options were considered for generating parking income and funding developments including electric car charging points across the County.

**Converting Agricultural Buildings** — information and the obstacles for local people were considered, and in 2017 the Cabinet Member was asked to lobby the Government in order to improve the situation.
