Cyllun Datblygu Lleol ar y Cyd Gwynedd a Môn

Mae Cyngor Gwynedd a Chyngor Sir Ynys Môn wedi paratoi dogfennau Cynllun Datblygu Lleol (CDLI) ar y Cyd ar gyfer y cynllun uchod. Bydd y CDLI ar y Cyd, ar ôl ei fabwysiadu, yn disodli'r cynlluniau datblygu presennol a bydd yn sail i benderfyniadau ar gynllunio defnydd tir ar gyfer Ynys Môn ac ardal Awdurdod Cynllunio Gwynedd.

Mae dogfennau'r CDLI yn cynnwys y 'CDLI ar y Cyd Adnau; Adroddiad yr Arfaniad o Gynaliadwyedd (sy'n ymgorffori'r Adroddiad Amgylcheddol) a'r Adroddiad Ymgyngħori Cychwynnol ynghyd â dogfennau ategol eraill.

Bydd Arolygydd annibynnol a fydd yn asesu pa un a yw'n 'gadarn' ai peidio yn ystyried y CDLI ar y Cyd Adnau. Ceir nifer o brofion cadernid ac mae'r rhain wedi eu nodi ar y ffurflen ar gyfer cyflwyno sylwadau neu yn Atodiad 1 y Cynllun Adnau. Dylai gwrthwynebiadau i'r CDLI ar y Cyd Adnau gyfeirio at y profion hyn lle bo hynny'n bosibl.

Dylai unrhyw sylw sy'n cynnig safle newydd neu estynedig ar gyfer datblygu neu un sy'n cynnig ymgorffori safle a wrthodwyd gan yr Awdurdod gynnwys gwybodaeth am gydweddoldeb y safle ag arfaniad o gynaliadwyedd y cynllun a'r graddau y caiff y gymuned ei chynnwys.

Gellid gyrru cais i anfon hysbysiad i gyfeiriad penodol o gam nesaf y CDLI ar y Cyd a/neu o'r ffaith bod y CDLI ar y Cyd wedi ei gyflwyno i Lywodraeth Cynulliad Cymru ar gyfer archwiliad annibynnol a/neu fod y cynllun wedi ei fabwysiadu.

Ni all yr Awdurdod Cynllunio Lleol newid y Cynllun ar y cam hwn ond gall benderfynu pa un a yw o blaid unrhyw gynigion a gynigiwyd.

Caiff sylwadau a wneir yn unol â'r hysbysiad hwn (h.y. 'eu gwneud yn briodol') eu hystyried gan Arolygydd annibynnol a benodwyd i archwilio cadernid y cynllun. The Isle of Anglesey County Council and Gwynedd Council have prepared Joint Local Development Plan (LDP) documents for the above plan. The Joint LDP will, upon adoption, replace the current development plans and form the basis for decisions on land use planning for Anglesey and the Gwynedd Local Planning Authority areas.

The Joint LDP documents include the 'Deposit Joint LDP', the Sustainability Appraisal Report (which incorporates the Environmental Report), an Initial Consultation Report together with other supporting documents.

Representations (including objections) in respect of the deposit Joint LDP, should be submitted through the consultation portal at www.gwynedd.gov.uk/lbp and www.anglesey.gov.uk/lbp or in writing using the official representation form by email to planningpolicy@gwynedd.gov.uk or by post to the Joint Planning Policy Unit, 1st Floor Bangor City Council offices, Ffordd Gwynedd, Bangor LL57 1DT by 5pm on 31 March 2015. Representations about the Sustainability Assessment or the Habitat Regulations Assessment should be submitted in writing to the above address by 5pm on 31 March 2015. Forms are available from the address below or online at www.gwynedd.gov.uk/lbp and www.anglesey.gov.uk/lbp

Representations (including those taking the form of objections) should specify the matters to which they relate. Objections should also specify the change sought, the grounds on which they are made and the test(s) of soundness to which they relate (see below).

The Deposit LDP will be considered by an independent Inspector who will assess whether it is 'sound'. There are a number of tests of soundness and these can be found on the form for making representations or in Appendix 1 of the Deposit Joint LDP. Objections to the Deposit Joint LDP should make reference to these tests wherever possible.

Any representation proposing a new or extended site for development or one that proposes to incorporate a site rejected by the Authorities should include information on the site's compatibility with the plan's sustainability appraisal and community involvement.

Representations may also be accompanied by a request to be notified at a specified address of the next stage of the Joint LDP and/or that the Joint LDP has been submitted to the Welsh Assembly Government for independent examination and/or of the adoption of the plan.

The Local Planning Authority cannot change the plan at this stage but it can decide whether it is in favour of any changes proposed.

Representations made in accordance with this notice (i.e. 'duly made') will be considered by an independent Inspector appointed to examine the soundness of the plan. Only those making representations seeking to change the deposit LDP (*i.e. objectors*) whose representations were 'duly made' have the right to appear before and be heard by the Inspector at the Examination (Section 64 (6) of the 2004 Act).
