Conducting the Assessment – Play Sufficiency Assessment

As well as establishing a baseline of provision, the Play Sufficiency Assessment will enable the following:

- Identification of gaps in information, provision, service delivery and policy implementation
- Support the establishment of evidence to give an indication of distance travelled in relation to play sufficiency
- Highlight potential ways of addressing issues relating to partnership working
- The input and involvement of all partners increasing levels of knowledge and understanding
- A monitoring system which will involve and improve communication between professionals
- The identification of good practice examples
- Increased levels of partnerships in assessing sufficient play opportunities
- The identification of actions for the Securing Play Sufficiency Action Plan which accompanies the Play Sufficiency Assessment

A template has been produced to support a corporate appraisal of the matters that need to be taken into account as set out in the Statutory Guidance. The indicators listed within each matter are provided as sample indicators which should be amended to meet local issues as appropriate.

The Play Sufficiency Assessment must demonstrate that the Local Authority has taken into account and assessed the matters set out in The Play Sufficiency Assessment (Wales) Regulations 2012 and Statutory Guidance.

As well as providing baseline information, the Assessment can include examples of current practice that the Local Authority wishes to highlight.

Principle Statement

Gwynedd Council recognises the importance of all aspects of play for the healthy physical, mental and social development of all children and young people in the county. We fully support strategies that protect and develop play opportunities, whether they are informal, structured or at the foundation phase and we are pesuaded of the added value and encourage communities to take the lead in developing their own plans.

It is necessary to ensure that all Gwynedd Council services continue to be aware of, and continue to recognise the importance of play and consider this element when making decisions on the provision of services.

As stated in the Assessment in 2016, one of the main challenges of carrying out and completing the assessment is the fact that there has not been a play officer in post since the beginning of 2015.

No county Play Working Group / Forum has met in the county since the Play Officer's post ended.

A new Play Forum will be created in 2022, with cross-departmental membership, to act on the recommendations of this assessment.

This Assessment was completed by the Early Years Unit Officers, led by the Assistant Head of Family Support and with the support of the authority's Education, Highways, Regional, and Research Departments.

Early Years Unit Officers are also responsible for the Childcare Sufficiency Assessment, with the timetable for both reports coinciding this year.

This has created difficulties in terms of work pressur, having to complete the reports while also dealing with a full work program and contiuniing the recovery work after the Covid pandemic, which is continuing.

A public consultation was conducted to ascertain the views of children, and parents / carers to support the assessment.

A consultation was held with partners (community councils, providers, agencies) also to steer the assessment.

The Assessment will be presented to the relevant Cabinet Member to ensure the cascade of messages through the authority, and to agree on the Action Plan at corporate level. The new Play Forum will own the Assessment / Action Plan.

The Assessment will be circulated internally through Corporate Communication arrangements and will be published on the Family HWB on the Gwynedd Council website for the public.

Partnership working

In order to complete the assessment and action plan it was important to get the views of a wide range of departments, providers and individuals in relation to the play situation in Gwynedd. A consultation was held in order to collect the views of partners, and was useful to gather contributions from different sectors. The contribution / consultations from different groups are set out below:

Questionnaires

- Community / Town Councils
- Play Providers and Associations (Public, Private and Third sector)
- Children / young people

Assessment Packages

- Gwynedd Council Departments
- Third Sector Organisations
- Public Sector

The questionnaires were promoted on the Council's social media through the Family Information Service.

• No response was received from a large number of the partners. The main weakness of the assessment is the lack of information about play opportunities / provision outside the local authority's services

Consultation and participation


The inclusion of Children, Young People and Families is at the core of the work of a large number of Gwynedd Council's services. The Council has an Engagement Strategy and a Corporate Engagement Panel to ensure that the views of residents is heard when shaping services, formulating strategies and influencing policies.

In order to complete the sufficiency assessment and ensure that the voice of children and young people have been included in the report, Gwynedd Council's Family Information Service distributed bilingual questionnaires to all Gwynedd schools.


As part of the consultation a separate questionnaire was also sent to community councils and partners outside the local authority.

Children's Questionnaires


A response was received from 368 children, from 28 schools across the County. A small number of responses were received from 23 of the schools, with between 1-4 responses. The largest number of responses were received from pupils in schools in Bangor, Caernarfon, Penrhyndeudraeth and Dyffryn Arduduwy



The age of the children who completed the questionnaire








Multiple answer: The percentage of respondents who chose each answer option (eg 100% means that all respondents to this question chose that option)

Do you get to play everywhere you want to?








Over 30% of children feel that they cannot play in some of the places they would like to play .






Play Sufficiency Assessment



11% of the children indicated that opportunities to play and socialise were not good, and that improvement was needed.

How has COVID-19, lockdowns and restrictions affected how you usually play?



Covid 19 has affected almost 80% of children's play opportunities

Gwynedd Council also consulted with Community Councils and partners outside the local authority.

9 Community Councils and 5 activity providers responded to the questionnaire.

10 of the respondents offered / provided play opportunities for children, with the majority providing playgrounds or green areas.

100% of the respondents stated that they did not have signs saying 'No Ball Playing', with one respondent stating that they did not use signs ' *Because we are keen to encourage children to use a ball to play',* and another respondent stating ' *Haven't had problems in the past and children should be free to play as they wish'*

Only 5 of the respondents stated that they collect the opinions and comments of children and young people when developing play opportunities/provision for the community.

9 of the respondents indicated that they had future plans for play opportunities / provisions, with additional comments including:

- Although the Council spent heavily on the two playing fields in recent years, there is still a bit of maintenance to be done such as replacing black floor tiles with wetpour, as it ultimately means less maintenance and prevents accidents
- Continuing with football practice sessions and the Urdd's weekly sports club. Organise a Summer plan
- Equipment needs to be fixed
- We want to develop a new playing field in the area, and also provide a Youth Club
- Review sites and consider upgrading/refurbishing play equipment where necessary
- We hope to restart our holiday clubs and we are applying for grants to hold sessions for families and children

Further comments about play provision / opportunities in Gwynedd included:

- We need corporate support for an organisation like ours to make applications and grants to develop a modern and high standard playground. We are not specialists in this and therefore need help in order to improve our chance of getting resources for children and young people so that they take pride in their community resources.
- Consider outdoor gym equipment
- The provision is very poor and difficult for the Town Council as Gwynedd Council are the owners of the land
- More play provision in all areas would be welcomed
- We would like to see an expansion of the methods used to provide skateboarding facilities to communities.

The results of the consultation were analysed and the conclusions inform the responses below. Gwynedd Council would like to thank everyone for their contribution.

Maximising resources

At the moment there is no core budget for Play from Gwynedd Council.

Grants received from the Welsh Government are the only source of funding to develop play opportunities set out in the Action Plans.

Until now there has been no specific structure to the grant funding, with different amounts being received at different times of the year, and at times having been received late in the financial year.

Although the grant funding is welcomed greatly, and has enabled many more developments and opportunities, it has made it difficult to plan and fund play opportunities that are sustainable in the long term.

There was a revenue and capital grant allocation in the 2020/21 financial year, but it was not received until the end of October.

Nevertheless, we collaborated with Community Councils and the officer with responsibility for the authority's playing fields, and there was an investment to upgrade and establish 7 community playing fields, and upgrade 5 Council playing fields.

An 'All Wales Play Opportunities Grant' revenue allocation was obtained for 2021/22, to be used to provide a range of activities during the school holidays.

In the meantime, the Welsh Government announced an additional **'Summer of Fun'** grant in June 2021 for activities between 1 July and 30 September, for children and young people aged 0 to 25.

The budget was specifically to support children and young people by providing play opportunities following the lockdown periods of the Covid pandemic.

Gwynedd Council used the budget in full and worked together with a number of stakeholders, including community groups to ensure play activities across the County.

Gwynedd Council secured specific funding for vulnerable children to have access to childcare, play provision and access to local attractions.

Following this, there was an additional **'Winter of Wellbeing'** grant allocation at the end of October 2021 to carry out activities between October 2021 and 1 March 2022, for children and young people aged 0 to 25.

As a result of receiving the 2 additional grants above, there was a change in spending plans from the previous revenue funding, with resource orders for specific training, thus ensuring that the grant was fully spent, and that other targets within the action plan were reached.

In addition, there was a capital grant allocation for October 2021, and once again there was collaboration with Community Councils and the officer with responsibility for the authority's playing fields.

Funding was provided to upgrade 8 community playing fields, and 6 Council playing fields.

From April 2022, confirmation has been received from the Welsh Government that the 'All Wales Play Opportunities Grant' will be allocated annually. Gwynedd Council has received an allocation of £38,754 for the 2022/23 financial year which will enable more long-term arrangements to be established.

The Government has also confirmed additional funding to support **'Summer of Fun'** again in 2022, to support the welfare of children and young people between the ages of 0 and 25. Participating in play opportunities, sports and cultural events will enable children and young people to continue to recover from the restrictions of the last two years, with the added benefit of supporting families with the costs of activities over the summer holidays.

Gwynedd Council also uses some of the Welsh Government's other programs to provide play opportunities.

eg Families First Grant, Flying Start, CCG, LAPA, Child Development Grant, to address some of the priorities of the latest action plan to provide opportunities for children with disabilities, target disadvantaged areas, and target underrepresented groups, and training packages for workers across care and play sectors / locations.

The Play Sufficiency Assessment and local WellbeingPlans

The Gwynedd and Anglesey Public Service Board has completed an Assessment that has looked at the wellbeing of communities in response to the Wellbeing of Future Generations Act (2015).

The Gwynedd and Anglesey Wellbeing Assessment published in May 2022 is based on thorough research and the main messages from engagement exercises with partners. It reflects priorities and challenges in areas across the two counties and contains information relating to a number of themes, including:

- population size,
- housing affordability,
- data on poverty and fuel poverty,
- the Welsh language,
- children's and young people's health,
- outdoor spaces,
- culture,
- climate change with the environment,
- a crime
- work and employment.

Over the coming months the Board will use the Wellbeing Assessment in order to create a new Plan that will guide the Board's work for the next five years. It is premature to identify what the main priorities will be within the new Wellbeing Plan and during 2022/23 the Board will consult with a number of stakeholders and partners, to ensure that its objectives are in line with local aspirations. The current Wellbeing Plan is in place until May 2023.

Monitoring Play Sufficiency

Lead Member – Councilor Elin Walker Lead Director:

Monitoring Play Group - there is no Play Monitoring Group at the moment but soon a Play Forum will be established to do the work. Governance arrangements for the field of children, young people and family support are being reviewed to reflect the priorities of the Local Public Services Board.

Insights from the Coronavirus

The covid restrictions have been a challenging time for children and young people in the country.

The play survey asked:

How COVID-19, lockdowns and restrictions have affected how you play as usual?

80% of children noted that Covid has had an impact on playing opportunities.

Comments included:

'Not going to friends' houses as often, after school clubs have started again'

'Made me more nervous about going out alone'

'Not allowed to see friends, used to not going out now. I talk on facetime and games more with my friends now'

'Covid stopped me from playing with my friends'

The biggest obstacles during this perioed was being able to organise face-to-face play activities, with constant changes in the restrictions.

Many parents were unsure about letting their children mix with others, and numbers attending any activities were very low, and at times sessions had to be canceled as everyone cancelled.

It was difficult for teams to engage with children and young people when they could not meet face to face. This also affected the ability to engage with communities.

Training courses were either postponed, or moved online.

With the need for a 'Playwork' qualification, for CIW requirements by registered providers from September 2022, not being able to hold face-to-face training sessions ;imited the numbers that could attend.

Matter A: Population

What has changed in terms of population and demographic trends since the 2019 Play Sufficiency Assessment?

Gwynedd Council's Research Department has produced population projections for the 8 wellbeingareas in Gwynedd:



Rhagamcanion

Poblogaeth Gwynedd.

It is estimated that the population of Gwynedd will rise by 6.1% from 2019 until 2043 which is around 7,600 more people.

An increase in the number of children under the age of 15 is predicted in 6 out of the 8 Wellbeing Areas between 2019 and 2043. Only Bangor and Dolgellau areas are expected to see a reduction: Bangor -20.8%; Dolgellau -14.3%.

The number and age of the children who receive assistance from Derwen, the Integrated Disabled Children's Team in Gwynedd has been set out below:

How has/will the Local Authority use its population data to plan for sufficient play opportunities locally?

The authority uses the data to targetand divert activities to reach disadvantaged areas; low income families; and disabled children.

Have there been challenges?

There have been gaps in our data, particularly information about the needs of gypsy and traveler children. However, an initial meeting at a traveler site in Bangor has recently been held to assess their play needs.

How can these be overcome?

Carry out further consultation with the Traveler Site Support Officer.

There is no Designated Play Officer in the authority to lead in the area of policy and who has qualifications in this area.

The authority has a play workforce across numerous services eg Early Years, Education, Children's Services and Youth Services.

The relevant Managers in the services ensure that the workforce is sufficient to provide play opportunities and is appropriately qualified - but that does not necessarily mean that all members of the workforce who provide play opportunities have qualifications. The relevant managers in the services are responsible for ensuring that play is part of their policy remit.

How has the Local Authority ensured that it understands and provides for the workforce development needs amongst the play workforce (as defined in *Wales: A Country That Creates Opportunity for Play).*

The relevant Managers in the services ensure that the workforce is sufficient to provide play opportunities and is appropriately qualified - but that does not necessarily mean that all members of the workforce who provide play opportunities have qualifications. The authority's resources (through a grant) prioritises qualifications and play skills among the early years workforce for its own workforce and the workforce of partners.

How has the Local Authority ensured that it understands and provides for the play workforce (as defined in *Wales: A Country That Creates Opportunity for Play).*

Every member of the council's staff goes through the evaluation process - and during the process and during supervision meetings with line managers there will be an opportunity to identify what the officer's training/qualification requirements are, and where possible when funding is available they will have the opportunity to attend courses/workshops.

The Early Years Unit ensures a development plan for childcare and play placements which includes training in play.

The collaboration in particular with the Health Board, Public Health Wales, Police in these two areas has seen more play opportunities being developed jointly, thus maximizing the use of new Resources (eg PACT, SBLASH) and has allowed us to prioritise and target specific areas and age groups.

Have there been challenges?

Emphasising the importance / role of play in some policy areas is more difficult due to the lack of awareness / recognition. There is no Structure (Play Forum) for bringing partners together.

How can these be overcome?

Conclusion

The responses of the public consultation carried out with children and young people should not be disregarded when guiding this Assessment.

On the whole the children responded that they play often, and have plenty of opportunities to play, in various locations. On the whole the children feel safe when they play and the respondents from the community welcome the fact that children play.

The main weakness of the play opportunities in the opinion of the children is the need for improvement to upgrade the play equipment in playing fields.

Over 76% of children played outside on most days at least. Over 80% of children indicated that they felt they had enough time to play outside, and almost 90% of children felt safe most of the time when playing and socialising.

88% indicated that the play opportunities available to them were ok, or good/great.

The main weakness of the play opportunities in the opinion of the children / young people was the need to improve / upgrade the playground equipment, and over 60% felt that some improvement was needed in the places where they played, with 2% stating that they were 'terrible'.

The Covid 19 pandemic has affected almost 80% of children's play opportunities.

The main priorities that have been identified from the assessment are that:-

That children and young people, on the whole are happy with the opportunities and play provision in the county.

Providers / community councils have plans for the future for play opportunities / provision, and the Council needs to support these where possible.

It is not possible to ensure inspections of access to play areas that are outside the Authority's stock

There is a reliance on grants in order to ensure Continuous Professional Development for employees involved in play

There is a lack of knowledge / understanding of the needs of some groups of children from ethnic minority backgrounds.

There is a need to continue to develop and promote information about locations / provision / play opportunities across the county in collaboration with the Family Information Service, and ensure that information is also shared withh Dewis Cymru.

There is further work to be done in certain policy areas in particular :

Improving children's opportunities in some schools to play when the weather is not favourable;

Ensuring that it is possible to provide access to the play resources of every school in Gwynedd throughout the year;

Need to promote the 10 step messages for a healthy weight as the obesity numbers for 5 year olds is high;

It is important to continue with the Inter-generational Plan, in order to maintain the momentum with the work. It will be necessary to ensure that the post of Inter-generational coordinator' is filled.

The Council's maintenance programs protect the existing stock but a number of the community councils have stated that they are keen to develop their playing fields with capital investments.

The Municipal Department does not have sufficient funding to upgrade / add to the equipment currently available in the parks, and there is a reliance on capital grants from the Welsh Government.

In terms of attracting other grants, this is not possible if the park is under the control of the Council. Grants eg Lottery are only available if the community group takes a lease on the park for a period, but this is not possible for a large number of communities as they do not have a reserve budget for maintenance.

When reviewing the areas that need upgrading, it is necessary to ensure that the range of equipment is suitable for children of different ages, and that they are suitable for older children as well as the smaller ones. Children's opinions and comments are key in developing play opportunities / provision for the community.

Way forward

The Action Plan below sets out the steps Gwynedd Council will take to address the areas identified above, taking into account the reliance on Welsh Government grants.
