**PS15 Settlement strategy**

The seeks to direct 55% of the Settlement Strategy Plan's housing growth to the sub-regional centre of Bangor, along with the urban service centres of Amlwch, Caergybi, Caernarfon, Llangefni, Blaenau Festiniog, Porthmadog and Pwllleli.

The urban service centres are diverse in terms of their size by population, role and function and availability of employment, leisure, retail, and other key services as well as their general accessibility by modes of travel other than the private car.

The plan should ensure that housing growth is directed to the largest settlements and areas on a proportional basis reflecting those settlements, size, role and function.

At present, it does not appear that the distribution of housing reflects the disparate size, role and function of settlements, and this is evident from the proposed allocations within Policy TAI14 later.

The remaining 45% of housing is to be distributed across the Plan area with 20% to local service centres and a further 25% to small villages and clusters. Whilst we recognise the need to provide housing across the Plan area, the provision of 45% of the housing requirement to small villages, settlements and clusters will result in a significant dispersal and diffusion of housing provision. This will result in housing provision to areas, with having limited opportunities for modes of travel other than the private car as well as limited opportunities for employment and key services and facilities, compared to the Urban Service Centres.

Furthermore, a larger proportion 25% of the housing requirement is to be directed to the lowest order settlements. This overall results in an "hour glass" form of spatial distribution.

The Policy therefore does not comply with Test of Soundness C2 as it does not comply with Planning Policy Wales & CE2 as it is not realistic having regard to other alternatives. Also the policy proposals does not reflect the approach of the WSP failing Test of Soundness C3.

**Proposed Change**

We consider that the housing spatial strategy should seek to direct at least 60% of the housing provision to the Sub Regional/Urban Service Centres, 25% to the local service centres and 15% to the villages and clusters. This will ensure that housing provision is directed to the most sustainable settlements in terms of access to employment, services, and day to day facilities by modes of travel other than the private car.

The Planning and Compulsory Purchase Act 2004 states that the purpose of the examination of a Local Development Plan (the Plan) is to consider whether it is "sound". Sound may be considered in this context within its ordinary meaning of "*showing good judgement*" and "*able to be trusted*". To assess the Deposit Plan we use 10 tests as set out above. The Deposit Plan will be examined by an independent Inspector appointed by the Welsh Government and it will be the Inspector's job to consider whether the Plan is sound.

Where you propose a change to the Deposit Plan you should therefore make clear which test(s) of soundness you believe the Deposit Plan fails. The tests are in 3 groups - 'Procedural' (2 tests); 'Conformity' (4 tests); and 'Coherence and Effectiveness' (4 tests). If you wish to comment on the way in which the Councils have prepared the Deposit Plan, it is likely that your comments or objections would fall under one of the procedural tests. Identifying Morfa Nefyn as a rural/coastal village where no allocations for open market housing are provided is considered unsound. National Planning Policy. Para 9.2.22 of Planning Policy Wales states LDPs should, in rural areas, provide "a choice of housing, recognising the housing needs of all, including those in need of affordable or special needs. PPW does not provide exclusively for local needs housing in settlements.

The designation (at Appendix 3) requires a greater proportion and provision of land to be available to provide housing to meet wider, open market needs, flexibility in the movement of the housing market as well as affordable housing. Allowing more open market housing at a limited level would not significantly impact on social or environmental capacity of the settlement not the Welsh Language.

In order to meet the scale of suitable growth set out the plan should provide greater flexibility and additional land within the development boundary for development. My Clients proposes 2 sites which would be a PPW and LDP/SA complaint extension to the development boundary to accommodate this. This would also reflect the view of the UDP inspector previously that the land could be suitable for future development needs.

A higher threshold should be provided to achieve certainty and deliverability in the policy objective to meet affordable housing targets.

3. The settlement boundary should be amended to include one or both of the sites (Twnti Site A and Twnti SiteB ) identified (forming part of candidate site SP52) as white land (being suitable for development within the settlement ) to provide flexibility for development needs over the lifetime of the LDP. The land could be either allocated as housing site or could be included within an adjusted development boundary to provide a housing site. (an SA has been carried out and is also attached) . Such an extension would be consistent with the preferred strategy, the SA, PPW (search sequence at paras 9.2.8 and 9.2.9, 9.2.22).

## Sylw Llawn / Full Representation:

Table 17 shows the JLDP's proposed distribution of housing growth. Strategic Policy PS15 expands on this, providing more information on type of development. Of the planned growth, 55% is to be centred on subregional centres and urban service centres. This drift towards the Bangor area and the A55 corridor has already begun, as shown by Appendix 5, which documents the number of units with planning permission on 1 April 2014. The concentration of planned growth along the A55 corridor will be associated with high car dependency. We consider that the current proposals do not adequately reflect national planning policy, which, to quote para 7.4.106 of the Deposit JLDP, "advises that local development plans should secure a sustainable settlement pattern which meets the needs of the economy, the environment and health, while respecting local diversity and protecting the character and cultural identity of communities". We also consider that, in the case of Bangor, insufficient attention has been given to the ongoing increase in student hall accommodation and its impact on the availability on the private market of housing that to date has been used as student accommodation.
