2. Ar 7fed o Awst 2024 mi wnaeth y Cyngor orchymyn a elwir yn Gorchymyn Diogelu Mannau Cyhoeddus Cyngor Gwynedd (Alcohol ac Ymddygiad Gwrth-Gymdeithasol) (Caernarfon, Cricieth a Pwllheli) 2024 (Gorchymyn Awst 2024)
3. Y mae'r Gorchymyn Gwella hwn yn newid Gorchymyn Awst 2024 i'r graddau bod yr Ardal Gyfyngedig yng Nghricieth yn awr i fodoli o fewn y linell las yn y cynllun sy'n atodol i'r Gorchymyn Gwella hwn. Dilëir y cynllun sy'n dangos yr Ardal Gyfyngedig yng Nghricieth yn yr Atodlen i Orchymyn Awst 2024 .
4. Wrth wneud Y Gorchymyn Gwella hwn y mae'r Cyngor yn fodlon eu bod wedi diwallu anghenion adran 59 o'r Ddeddf .
5. I phob perwyl arall y mae Gorchymyn Awst 2024 yn parhau i fod mewn grym ac yn ddigyfnewid.
6. Daw'r Gorchymyn Gwella yma i rym ar y dyddiad y mae'n cael ei wneud ac parheir hyd 6ed o Awst 2027.

Gwynedd Council ("the Council"), in exercise of the powers conferred upon it by sections 59 and 61 of the Anti-social Behaviour, Crime and Policing 2014 (the Act) makes the following Order:

1. The name of this Order is the Gwynedd Council Amendment (Alcohol and Anti-Social Behaviour) (Caernarfon, Cricieth and Pwllheli) Public Spaces Protection Order 2024 (this Amendment Order).
2. On 7th August 2024 the Council made the Gwynedd Council (Alcohol and Anti-Social Behaviour) (Caernarfon, Cricieth and Pwllheli Public Spaces Protection Order 2024 (the August 2024 Order).
3. This Amendment Order changes the August 2024 Order to the extent that the Restricted Area in Cricieth is now located within the blue line on the map attached to this Amendment Order, and the map found in the Schedule to the August 2024 Order showing the Restricted Area as to Cricieth is deleted.
4. In making this Amendment Order the Council are satisfied it has fulfilled the requirements of section 59 of the Act.
5. In all other respects the August 2024 Order is unchanged and effective
6. This Amendment Oder shall come into force on the day it is made and it shall remain effective until 6th August 2027.
