Executive Summary

Our vision:

'The people of North Wales can live safe, equal and violence-free lives, in communities without abuse or exploitation'.

North Wales is working together to tackle all aspects of Violence Against Women, Domestic Abuse, Sexual Violence, Modern Slavery, Human Trafficking, Organised Immigration Crime and Exploitation.

The North Wales Vulnerability and Exploitation Board represents all statutory and non-statutory partners across the region, committed to a collaborative, joined-up approach to addressing all areas of vulnerability and exploitation.

The North Wales Vulnerability and Exploitation Strategy 2021-2024 involves a multi-agency approach to addressing vulnerability and exploitation in North Wales. Both Violence Against Women Domestic Abuse and Sexual Violence (VAWDASV) and Modern Slavery agendas are aligned to the four Strategic Aims:

PREPARE PREVENT PROTECT PURSUE

The Strategy enables and supports innovative practices and ideas, as well as supporting existing services, to provide a cohesive package of support for victims, survivors and their families. The Strategy also ensures perpetrators are held to account and supports communities to promote an ethos of safety, equality and well-being.

Introduction

The North Wales Violence Against Women, Domestic Abuse and Sexual Abuse Strategic Board met for the last time in Spring 2020, due to a complete reform of the Strategic Board structure across North Wales. Following a substantial amount of work and consultation, it was decided that the VAWDASV agenda would joint with Modern Slavery, Human trafficking, Organise Immigration Crime and other areas of criminal exploitation. The new arrangement is called the Vulnerability and Exploitation Board.

A new Strategy was developed in 2020/21, which gives clear strategic aims for the region and under that is a Delivery Plan, showing short, medium and long-term objectives. This is currently being updated, to show the connections to the new All Wales VAWDASV Strategy and the Blueprint.

The Vulnerability and Exploitation strategy clearly shows that North Wales is committed to tackling exploitation of the most vulnerable in our society and is a priority for all partners within the statutory and non-statutory sectors.

The North Wales Vulnerability and Exploitation Partnership Board is a strategic network of agencies aligned across all six Local Authority Areas of North Wales (Anglesey, Gwynedd, Conwy, Denbighshire, Flintshire and Wrexham), comprising statutory, non-statutory and third sector organisations.

The purpose of the strategic partnership is to generate a coordinated, efficient and productive response to tackle Violence Against Women, Domestic Abuse and Sexual Violence (VAWDASV) and Modern Slavery, Human Trafficking, Organised Immigration Crime and Exploitation. We will achieve this by:

- Working collaboratively to ensure that individuals within our communities who may be vulnerable and/or subject to exploitation are identified and heard in order to achieve the best outcome for them.
- Building trust and confidence through working alongside and within our communities.

The Vulnerability and Exploitation Board is designed to capture and guide the partnership work, as well as overseeing the delivery of the strategy objectives, by all partnership agencies, under the Regional Strategy as well as relevant national legislation.

The current Strategy encompasses the work already being done under the Violence Against Women, Domestic Abuse and Sexual Violence agenda, as well as other areas of exploitation. It does not dilute the previous work done under the direction of the VAWDASV Board, but rather supports us to consider the agenda from a more holistic perspective, developing new areas of collaboration, both from a delivery aspect, as well as investigating new opportunities for joint commissioning.

Governance

The North Wales Vulnerability and Exploitation Partnership Board will be accountable for the Vulnerability and Exploitation Board Strategy. Chaired by the Chief Executive, North Wales Office of the Police and Crime Commissioner, the Strategic Partnership Board provides oversight, direction and support to local partners to ensure a collaborative approach. The Board meets on a quarterly basis to monitor and evaluate progression towards the Strategic Aims and Objectives as outlined within the Delivery Plan and Actions. The Work Streams will, in turn address the aims and objectives within the Delivery Plan and move the work forwards in each of the agenda areas, reflecting the work directed by the national VAWDASV work streams. This work will then be reported back to the Strategic Board and Welsh Government on a quarterly basis.

The Vulnerability and Exploitation Partnership Board Chair meets with counterparts from the Safer North Wales Partnership Board, Safeguarding Boards (Adults/Children), Contest Board, Local Criminal Justice Board, Area Planning Board and Regional Leadership Board to ensure alignment of work streams.

Specific areas of progress during 2022/23

2022/23 saw a huge increase of referrals to the specialist sector, as victims and survivors found the confidence to seek support following the lifting of restrictions linked to the Covid-19 pandemic. Services saw increases of up to 50% across the board and waiting list inevitably increased for some specialist and therapeutic services. However, it was also a year of increased resource, not just from Welsh Government, but funders such as the Ministry of Justice and the Home Office, so North Wales saw the largest amount of VAWDASV related funding coming into the region since regionalisation.

The National Training Framework became fully embedded within the annual training plans of the Local Authorities, BCUHB and NWFRS, with completion rates climbing rapidly. Ask and Act Champions (Group 3) were still slow in coming forward, but this has gradually increased over the 12 months.

The IRIS pilot in the South Denbighshire cluster of GP surgeries has been a resounding success, with over 100 GPs and staff receiving enhanced training and support to recognise domestic abuse and make referrals for early intervention. We hope to see this rolled out across the Central region in 2023/24 and then across the wider region over the next 2 years, although sustainable funding is always a concern.

The North Wales VAWDASV Needs Assessment was completed during this period, showing the rapid increase in referrals to the specialist sector and the need for increased join up of funding, to ensure efficient and effective commissioning of services. A wider range of provision is available than ever before, with recovery programmes embedded into the existing provision across the region.

Children and Young people affected by VAWDASV have been a priority over the last year and there are now specialist Children and Young People's Workers embedded within more of the services than ever before. They offer a wide range of support, including one to one support, as well as play therapy within the refuges and targeted group programmes in many schools across North Wales.

The capital funding for disbursed units was used to address a previously unmet need that of families fleeing abuse over the weekend or out of hours. Many families have been forced to stay in local hotels if refuges don't have space and this means they have no kitchen facilities, space for pets etc. There is now a specific building allowing large families to have a real "home" environment, while they wait for appropriate longer term provision. This increases the chances of them making the final move away from an abusive parent, but also gives them the opportunity to function as a family unit within their own space.
