From 1 January 2021, the Port of Holyhead cannot process ATA Carnets, so you'll need to go to Roadking Truckstop when moving goods with an ATA Carnet. Roadking Truckstop will also offer Office of Destination and Office of Departure services.

Make sure you get ready before you travel to the Roadking Truckstop by using an Authorised Consignor or Consignee to start or end your transit movement.
