We want your views on plans to improve walking, cycling and wheeling provision near the A487 Faenol Roundabout, Bangor.






1 Overview

The North and Mid Wales Trunk Road Agent (NMWTRA), working on behalf of Welsh Government, are consulting on proposals to make it safer, easier, and more convenient for people to walk, wheel and cycle near the A487 Faenol Roundabout. Mott MacDonald and Cyngor Gwynedd are supporting NMWTRA to deliver this scheme. The scheme has been developed in more detail following previous consultation with key stakeholders.

This scheme aims to improve the active travel infrastructure at Faenol Roundabout and on the approaches from the B4547 and A487 Faenol Hill. The area of interest is shown below.

The scheme will complete a missing link in the local network, providing better access to existing routes such as Lôn Las Menai, Lôn Adda and Penrhos Road.

This document provides details of the scheme and how to give feedback. We welcome all feedback and will, where feasible, incorporate any suggestions.



Wider context

This scheme is part of ambitions by NMWTRA, Welsh Government and Cyngor Gwynedd to improve walking, wheeling, and cycling for everyday journeys. Providing these facilities will help to improve choice and access to opportunities for everyone. In the context of climate change and the ecological emergency, it is more important than ever that people feel they can access more sustainable forms of travel.

2 About this scheme

We know people already walk and cycle through this area to and from Bangor and places such as Y Felinheli. But we have been told the existing crossings at Faenol Roundabout are unsafe, and the walking and cycling path on Faenol Hill is too narrow. This is putting pedestrians and cyclists at risk, and deterring others who would like to walk, wheel and cycle more.

To address this, we are proposing phased improvements:

Phase 1 (delivered from 2025)

Signalisation of the A487 (T) and A487 (Faenol Hill) arms of the roundabout, with Toucan crossings over the exit and entry arms of the northern arm

Localised speed limit reduction from 60mph to 50mph on all approaches to Faenol Roundabout

Widening of the shared use path on the B4547 which connects to the roundabout



Phase 2 (to be delivered later)

Widening of the shared use path on Faenol Hill as far as Penrhos Road junction. This will include a margin strip to provide safe separation from the carriageway

Improvements to Penrhos Road junction which will connect to an ongoing active travel scheme being constructed on Penrhos Road

We recognise that signalising some arms of the roundabout may be a concern for drivers. We have tested the impacts of this with transport modelling software. This analysis found that signalisation could help to better manage busy traffic flows, making it safer and easier for vehicles to enter the roundabout from the B4547 and A4087 (which will remain uncontrolled).


Statement on General Data Protection Regulation (GDPR)

We take a robust approach to managing information received from all parties. We have a wide range of well-established and certified systems and processes in place to ensure compliance with the General Data Protection Regulation (GDPR). We follow Data Security ISO27001 protocols via BMS to ensure we comply with GDPR requirements, store data securely, and maintain confidentiality where required. All digital project information is stored in secure fileshare spaces such as SharePoint and ProjectWise, with access only for those within the project team. These tools also support secure online sharing of large documents with clients.

When personal information reaches the end of its designated retention period and is no longer required for a lawful business purpose, it is securely deleted or destroyed. All our systems incorporate the functionality required to securely delete personal information in accordance with agreed pre-configured retention periods.

We use an external service provider to manage the cleansing and destruction of obsolete or faulty digital storage media owned by Mott MacDonald. Destruction certificates are provided to evidence the completion of the destruction process. The supplier is accredited under the NAID AAA Certification Program.

Hard copy (i.e., paper based) records containing personal information are either destroyed using commercial grade shredding machines in our office premises or collected by an external service provider in sealed containers before being securely transported to their premises for destruction.
