3. Diddymu cyfyngiadau aros ar yr ochr darn ffordd a bennir yn Atodlen 2 isod
4. Bydd eithriadau yn caniatâu aros o dan rhai amgylchiadau fel y nodi'r yn y Gorchymyn drafft.

THE CYNGOR GWYNEDD
(PROHIBITION AND RESTRICTION OF WAITING AND STREET PARKING PLACES)
(ARFON AREA NO. 29) ORDER 2025

The Cyngor Gwynedd propose to make the above Order in exercise of the powers conferred by the Road Traffic Regulation Act 1984, as amended and of all other powers them enabling and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Road Traffic Regulation Act 1984.

The effect of the Order will be to:-

1. Prohibit and restrict vehicles from waiting on the sides of lengths of the roads referred to in Schedule 1 hereto.
2. The part of road specified in Schedule 1 hereto shall be used as a parking place for a disabled person's vehicle displaying a disabled person's badge
3. Revoke the waiting restrictions on the sides of lengths of the roads referred to in Schedule 2 hereto.
4. Exceptions will permit waiting in certain circumstances as set out in the draft Order.

Full details are contained in the draft Order which, together with the maps showing the lengths of roads concerned and a statement of the Council's reasons for making the Order are available.
