The Council is required (under the Equality Act 2010) to consider the effect that a change in any policy or procedure (or the creation of a new policy or procedure) will have on people with protected equality characteristics. I) Details

I.I What is the name of the policy / service in question?

Create two Orders: Traffic Management Order under section 1 and 32 of the Road Traffic Management Act 1984

1.2 What is the purpose of the policy/service being created or changed? What changes are being considered?

Provision of parking spaces for vehicles (self-contained motorhomes) to stay overnight in designated areas in four car parks, namely the Shell Caernarfon Site, Y Maes Criccieth which are already car parks and Ffordd y Gogledd Pwllheli and Y Glyn Llanberis Site which are to be are new car parks.

As part of the scheme, there is an intention to offer suitable provision to dispose of gray waste and obtain fresh water (if practically possible in all locations). We will also ensure that there are a sufficient number of bins for general waste and recycling.

These locations were chosen following checks e.g. no negative impact on residents, there is spare capacity in the car parks and locations outside the flood zone.

This is the main purpose of our service in terms of enforcement:

- To facilitate traffic flow and contribute to having safe and unobstructed lanes. A large number of motor home owners choose to park on sections of the highway including byways and residential streets. The 'Arosfan' scheme was established in response to our Communities' desire to have better control of vehicles of this type.
- Encourage a high level of compliance by motorists in accordance with the parking controls and restrictions.
- > Being responsive to changing priorities, local factors and demand.

2) Action

2.1 Who are the stakeholders or partners who will have to work with them to make this assessment?

We will need to collaborate with the Town or Community Councils, Local Members, North Wales Police, Fire Services, Transport Services and representatives from the Motor Home Sector.

2.2 What steps have you taken to engage with people with protected characteristics, regarding the Welsh language or with communities (either because of location or because of need) who live with socio-economic disadvantage?

The consultation process and giving notice in the press is part of the procedure and members of the public can submit their comments or objections or give a positive opinion through this statutory process.

It is an essential requirement for the Council to advertise the proposed changes in the local newspapers as well as display the information (including the new fees) in a prominent position in the car parks that will be affected.

In order to introduce provision for motorhomes in the locations indicated above, the Council had to submit applications for planning permission. During this process, there is a consultation period which invites Members of the Public including car park users, general motorists, residents, businesses including caravan parks, Local Members, Town and Community Councils, Emergency Services to share comments or state any concerns.

2.3 What was the outcome of the consultation?

No objections were received during the consultation process before planning permission was granted.

In 2021 the Council's Environment Department and the Economy Department worked together and carried out an investigation into the subject.

As part of this investigation, Cyngor Gwynedd's Tourism, Marketing and Events Service carried out online research with owners of caravan and camping grounds in Gwynedd. The purpose of the research was to find out more about the county's camping provision and find out local opinions about the situation.

As part of the consultation, research work was carried out in order to ascertain the opinion of the residents and communities of Gwynedd on the motor homes situation locally. The research was carried out online for a period of 6 weeks during the Summer.

4,868 questionnaires were completed, 2,169 complete questionnaires. Responses were received from a cross section of residents across Gwynedd including Arfon, Dwyfor and Meirionnydd.

Based on the evidence resulting from this work, it is believed that better management of the motor home sector in Gwynedd is needed and that the following recommendations should be considered:

• Using public assets such as public car parks in appropriate destinations in order to trial 'overnight' parking provision for the purpose of motor homes (this will of course be subject to the need for planning permission, site licence)

• A trial to look at the possibility of using current car parks where simple modifications can be made to provide basic services such as fresh water, toilet emptying, gray water and rubbish.

There has been a significant increase in the number of motor homes registered in Britain by the DVLA. Communities in Gwynedd have expressed concern about the numbers of these vehicles that decide to park on parts of the public highway, residential streets etc. The intention of the proposed changes is to try to get better control of the situation.

The pilot scheme in question is the first of its kind throughout Wales so we will continuously monitor the situation and introduce adjustments as appropriate.

2.4 What other evidence do you act on?

There is no doubt that the COVID-19 pandemic has contributed significantly in driving the increase in motor home sales and hire. The regulations and restrictions on traveling abroad on holiday have increased the demand for the British 'Staycation'.

The increase in visits by motor home owners has not gone unnoticed here in Gwynedd and concerns have been raised in a number of communities across the county as an increasing number of motor home owners decide to stay in locations and on 'public' land. where there is no legal right to sleep in a vehicle overnight. The Council's Environment and Economy Departments have mainly received a significant number of complaints and allegations related to the attitude of some motor home owners e.g. parking irresponsibly, leaving general rubbish as well as human waste behind and taking valuable parking spaces on residential streets.

The Council does not allow people to sleep overnight in their vehicles at the moment. In order to alleviate some of the problems above, we believe it is timely and sensible to introduce suitable provision in an attempt to improve the situation. There was also a large number of requests from motorhome owners for provision of this type and confirmation that they were willing to pay a fee for a safe site to park and sleep overnight.

It appears that there is quite substantial provision for meeting camping needs in Gwynedd. Despite this, it must be noted that a large number of caravan and camping sites now operate on the sale of seasonal pitches / 'seasonal pitches' to caravan owners which means a significant reduction in the number of touring pitches available which do not match the needs of home owners a motor that prefers more freedom and moving from one place to another often.

2.5 Are there any gaps in the evidence that needs to be collected?

We believe it is premature to be able to report on the gaps. The result of the pilot will give us more information to be able to report as required.

		It is expected for the provision to be used by Welsh people in addition to people from other Countries.
Socio- Economic Disadvantage	Positive	By doing this we are promoting tourism, and helping public health. The Town Councils will receive 10% of the income generated from the new scheme. The income will be spent on Community projects or benefits.
		Research with motor home owners shows that a large majority are keen to stay overnight in more urban locations in order to be close to services such as shops, restaurants etc. They also tend to stay an average of 2 nights before moving on.
		It also shows that camping sites allow people to turn up without booking in advance and prefer to sell pitches for a long period. The Council has therefore identified a gap in the market in order to address this need.
		A fee of £15 per night has been established for vehicles wishing to use the Stop scheme. We believe that the fee is reasonable because it is much cheaper than a camping site but cheap enough to encourage people to use it and park responsibly. We will of course monitor the suitability of the fee as the scheme matures.

We will ensure that we take advantage of every opportunity to promote and showcase the Welsh language. There is an expectation that people from Wales as well as people from other countries will use the Arosfan provision.
