The reason for this that there are only 8 children at the school.

There are only 2 learners in the nursery class and 6 full time learners.

We would like to know how you feel about the plans for Ysgol Baladeulyn and Ysgol Talysarn.

What is proposed?

The proposal for the Nantlle area is to close Ysgol Baladeulyn and offer learners a place at Ysgol Talysarn.

Close Ysgol Baladeulyn

Transfer learners to Ysgol Talysarn



What does this change mean?

If the Cyngor Gwynedd's Cabinet decides to close Ysgol Baladeulyn...

Rather than go to Ysgol Baladeulyn, learners will have the option to move to Ysgol Talysarn which is around 2.5 miles away.

Cyngor Gwynedd believes that this proposal will strengthen future education for the area.

Moving to another school would mean:

- An opportunity to meet and play with new friends
- More children of the same age
- More children to help each other
- More teachers
- Give each child fair experiences
- You will know more children when it's time for you to move to secondary school.



Steps

Statutory Consultation period 10 December 2025 - 28 January 2026

An opportunity for anyone to comment on the proposal

Cabinet - Report back to the Cabinet with comments received

The Cabinet will decide if it will press ahead with the proposal or not



If the Cabinet decides to go ahead, an 'Objection Period' of 28 days will begin.

There will be an opportunity for you, and anyone who wishes, to object to the proposal during this time.



Following the objection period, the Cabinet will make a final decision

What do you think of the proposal?

Before Cyngor Gwynedd decides on the way forward, we want to hear your views on the proposal and plans for Ysgol Baladeulyn and Ysgol Talysarn.

How can you respond?

Anyone is welcome to send comments to the Council to express their views or complete a questionnaire.
