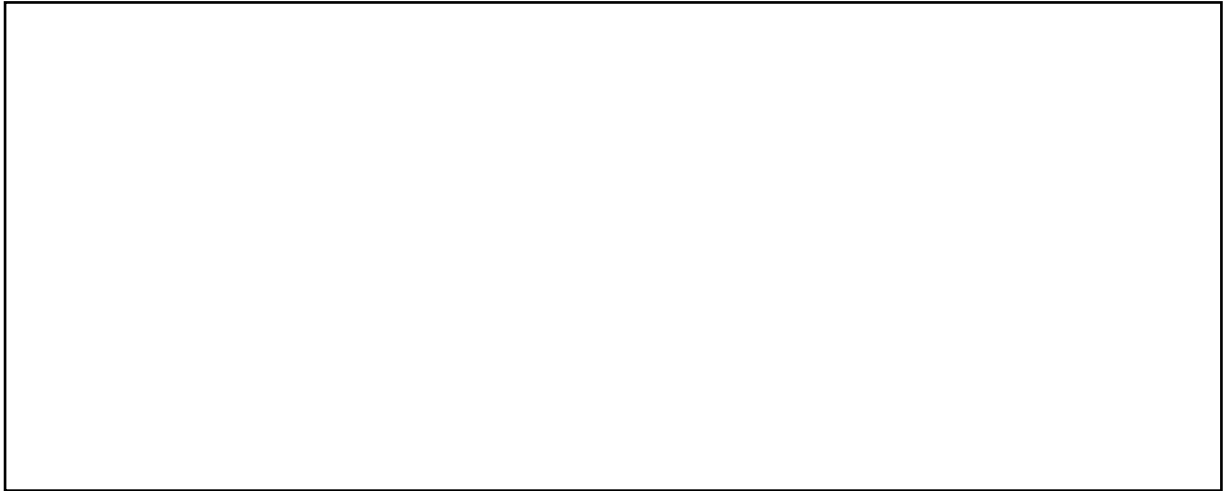

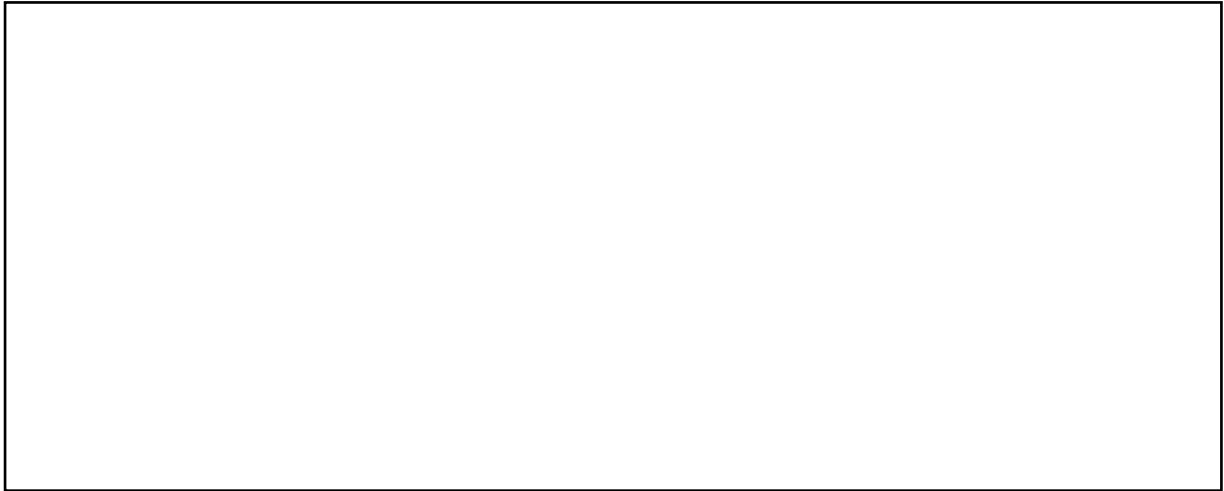

- Variation in the quality of provision and outcomes leading to a lack of consistency in the opportunities and experiences provided for learners across the county.
- Small teaching groups in many subjects and a lack of peers to enhance the learning experience.
- Challenges to achieving a true choice of 30 courses due to practical constraints and the restraint of individual school offerings.
- The challenge of securing a post-16 education system that makes efficient use of funding resources, ensuring equality of opportunity for all learners.
- Challenges to ensure that learners take advantage of the provision of courses available through the medium of Welsh and bilingually.
- Opportunity to attract investment of up to £18m to improve post-16 education provision through the Welsh Government's 21st Century Schools and Colleges Programme.
