## NOTICE OF PROPOSAL TO MAKE REGULATED CHANGES TO YSGOL CHWILOG

YSGOL CHWILOG, CHWILOG, GWYNEDD LL53 6PS

Notice is hereby given in accordance with section 42 of the Schools Standards and Operational (Wales) Act 2013 and the School Organisation Code that Cyngor Gwynedd, after consultation with such persons as required, propose to extend the site by increasing the capacity of Ysgol Chwilog, Chwilog, Gwynedd LL53 6PS, from 65 to 95 pupils from 1 September 2023. The school is maintained by Gwynedd Council.

Cyngor Gwynedd undertook a period of consultation before deciding to publish this proposal. A report on the consultation containing a summary of the issues raised by consultees, the proposer's responses and the views of Estyn is available on the Councils website [www.gwynedd.llyw.cymru/modernisingeducation](http://www.gwynedd.llyw.cymru/modernisingeducation)

It is proposed that this proposal is implemented on **1 September 2023**. The proposal will be implemented by the Local Authority.

The admissions authority for the 3-11 school will be Cyngor Gwynedd. Pupils will be admitted to the school by Cyngor Gwynedd in accordance with the Admissions Policy. The admissions arrangements for the school will not make provision for selection by aptitude or ability (pupil banding).

The number of pupils in the school was 84 on September 2022 including Nursery pupils. The pupil capacity for the school (referred to the Welsh Government Circular 21/2011 'Measuring the Capacity of schools in Wales') is 65. After implementation of the proposal there will be a provision for 95 pupils from Reception to Year 6 and 13 full time nursery places. The admission number for 1 September 2023 will be 13 Reception to Year 6 pupils with 13 full time nursery places.

Any person may object to the proposal, within a period of 28 days from the date which the proposal is published, that is by **8 March 2023**.
